Meeting Purpose: To provide the advisory board and the public with information about special education issues to help improve special education and related services for children with disabilities within the Bureau of Indian Education (BIE) school system; and to meet the mandates of Individuals with Disabilities Education Improvement Act (IDEA).

Special Education Advisory Board Function: The duties are solely advisory and are to:

- Assist in the coordination of services within the Bureau of Indian Affairs and the BIE with other local, State, and Federal agencies in the provision of education for infants, toddlers, and children with disabilities.
- Advise and assist the Secretary in the performance of the Secretary's responsibilities described in section 611(h)(6) of IDEA.
- Develop and recommend policies concerning effective inter- and intra-agency collaboration, including modifications to regulations, and the elimination of barriers to inter- and intra-agency programs and activities.
- Provide assistance and disseminate information on best practices, effective program coordination strategies, and recommendations for improved early intervention services or educational programming for Indian infants, toddlers, and children with disabilities.
- Provide assistance in the preparation of information required to be submitted under section 611(h)(2)(D) of IDEA.
- The Board shall prepare and submit to the Secretary and Congress an annual report containing a description of the activities of the Board for the preceding year. The Secretary shall make this annual report available to the Secretary of Education.

Meeting Outcomes/Objectives: Collect special education information from panelists, develop the advisory board agenda for the June 22-23, 2023 meeting; discuss and develop priorities to work on.

Supplementary Information: This advisory board is authorized under the provisions of the Public Law 108- 446 IDEA of 2004, Part B, Sec. 611(a)(6); Sec. 612(a)(21)(A); and is regulated by the Federal Advisory Committee Act of 1972 (5 U.S.C. 10); and the Government in the Sunshine Act of 1976 (5 U.S.C. 552b, as amended).
