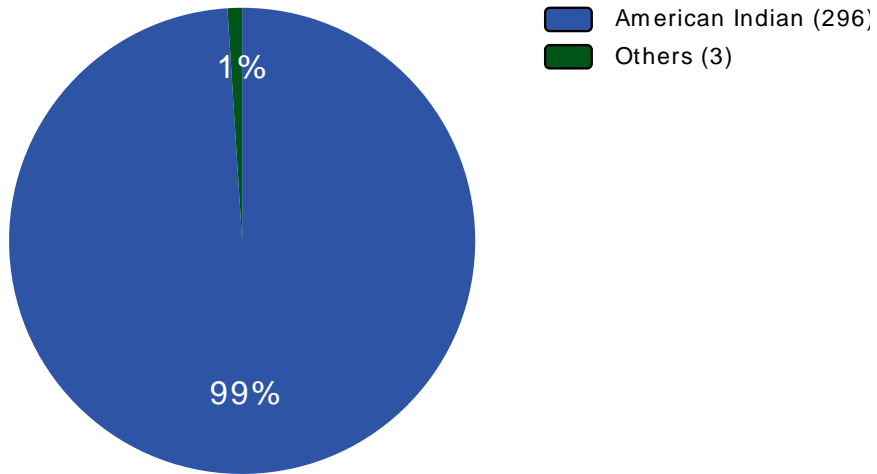

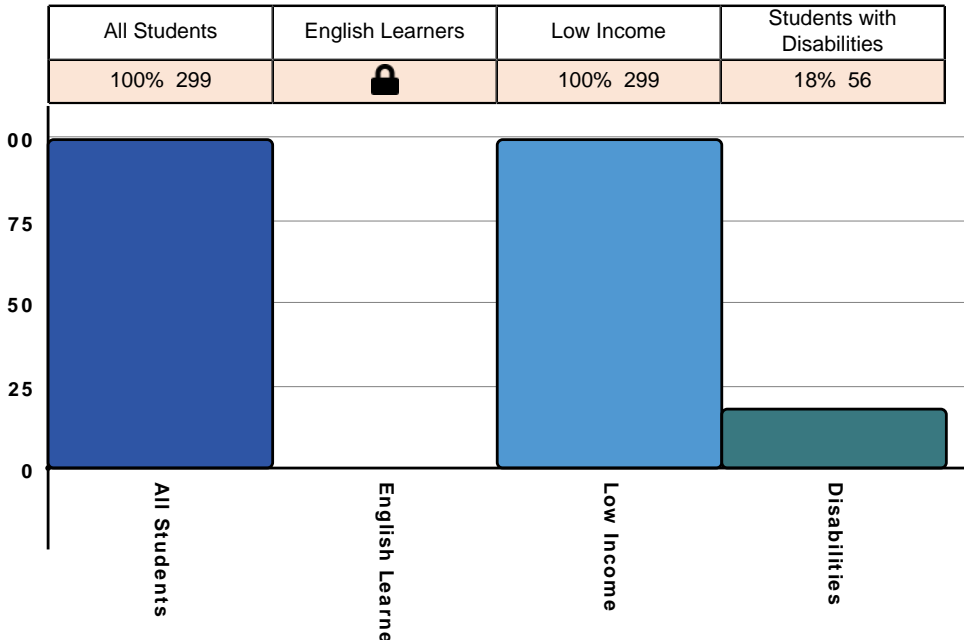

### Enrollment by Race/Ethnicity



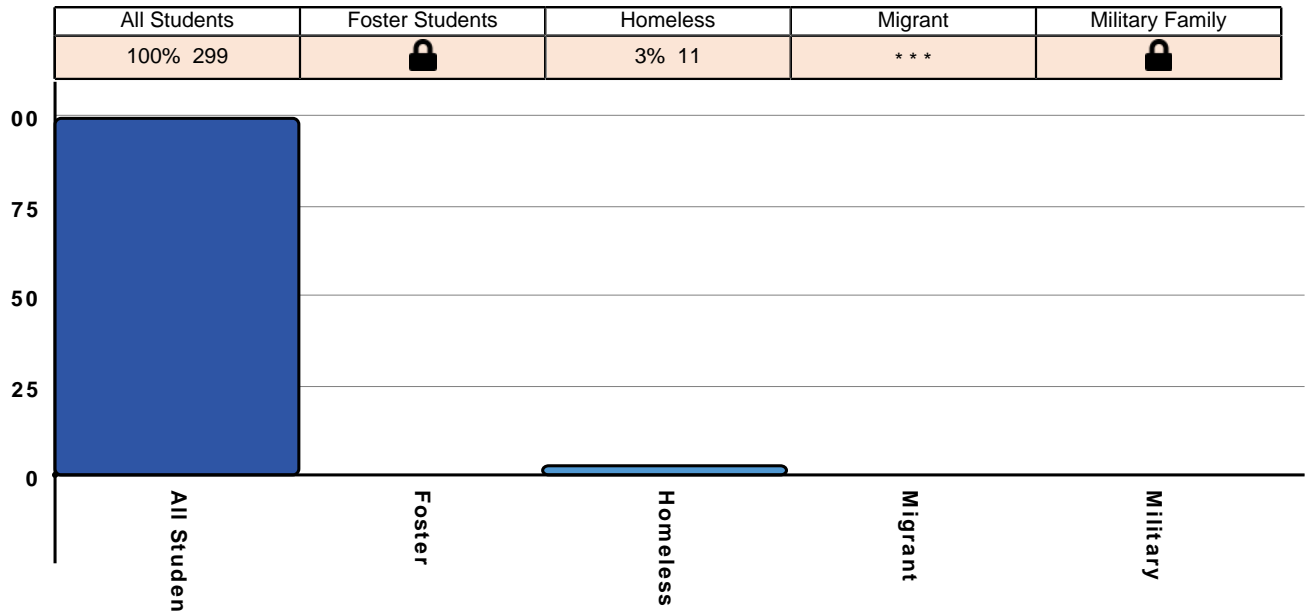

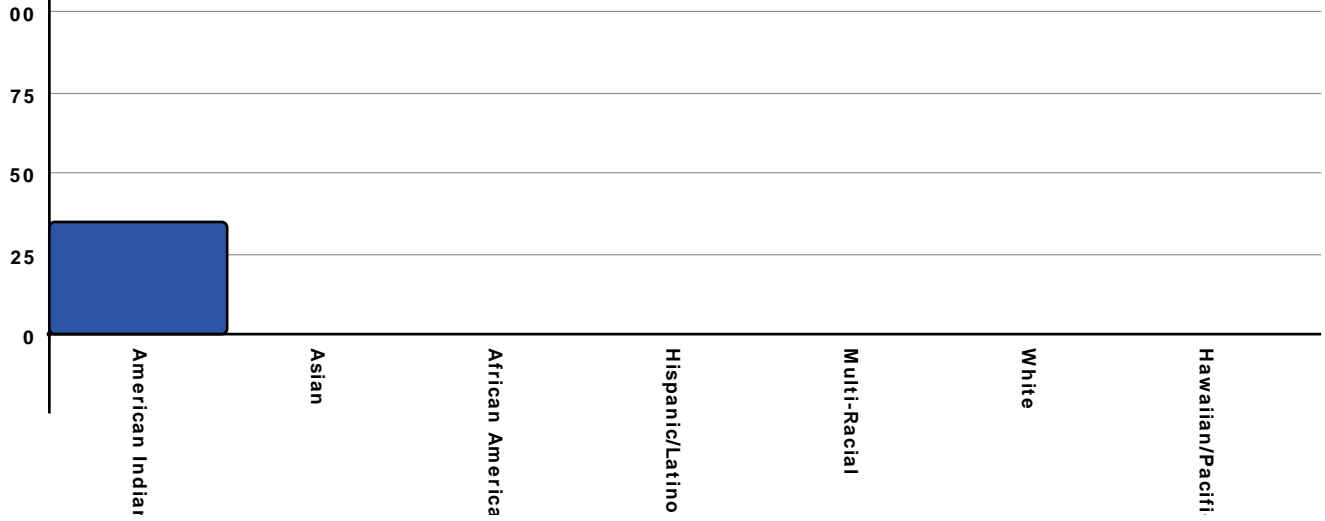

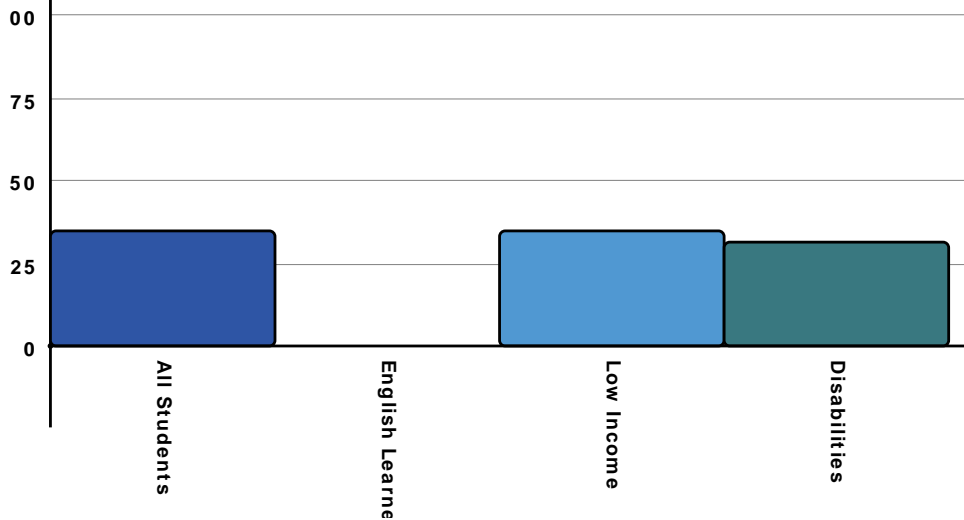

On Track Attendance by Other Characteristics

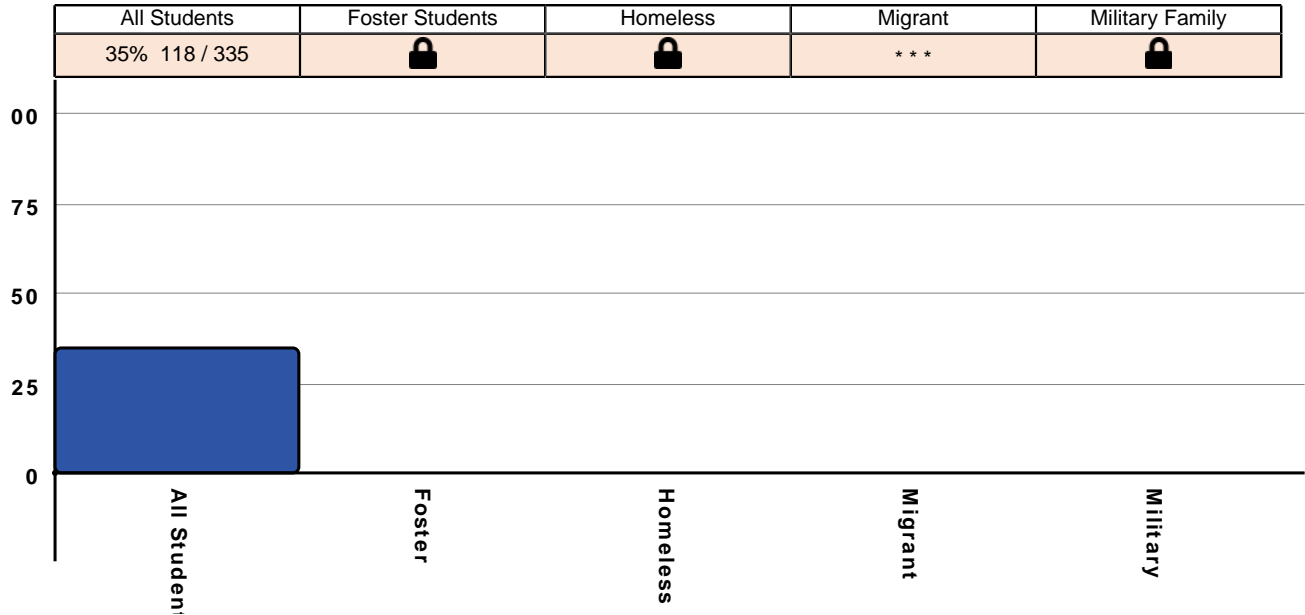

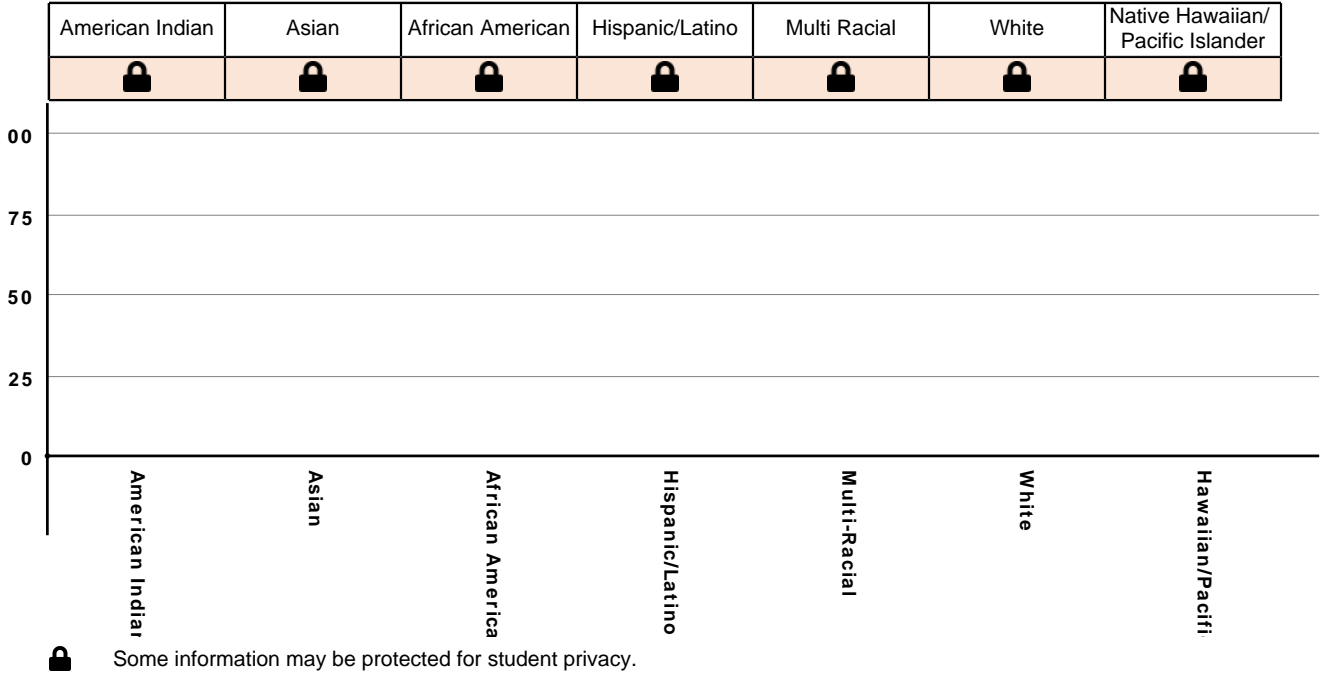

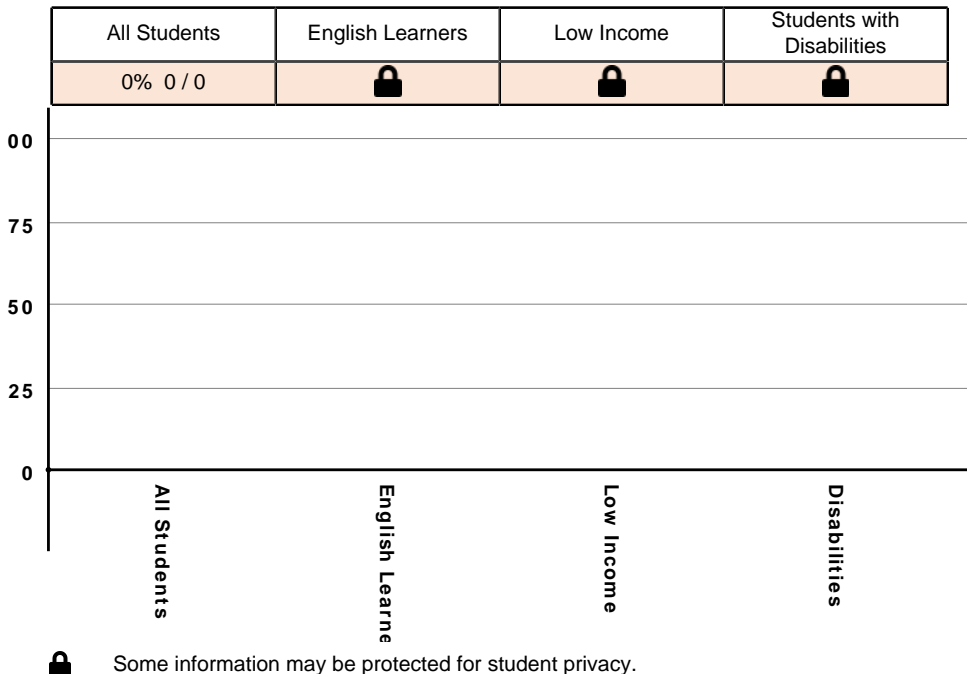

In accordance with US Department of Education requirements, the Bureau of Indian Education uses the 4-year adjusted cohort graduation rate which is defined as the number of first-time 9th grades who graduate with a regular high school diploma in 4 years. Graduation rates do not include students who earn alternate diplomas or certificates of completion.

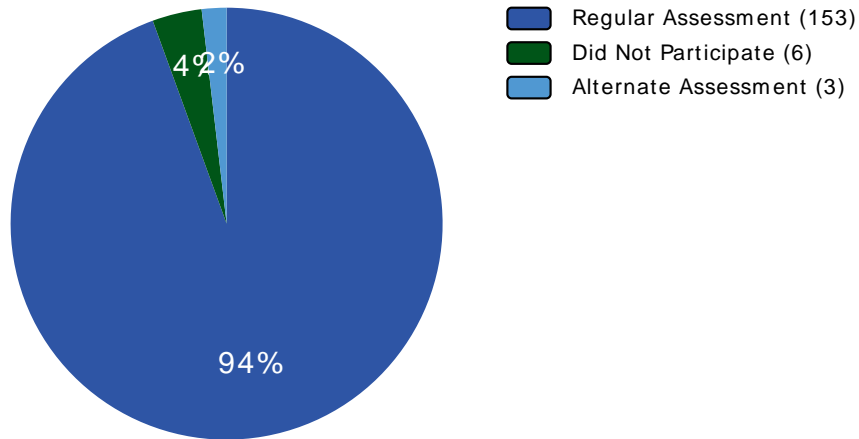

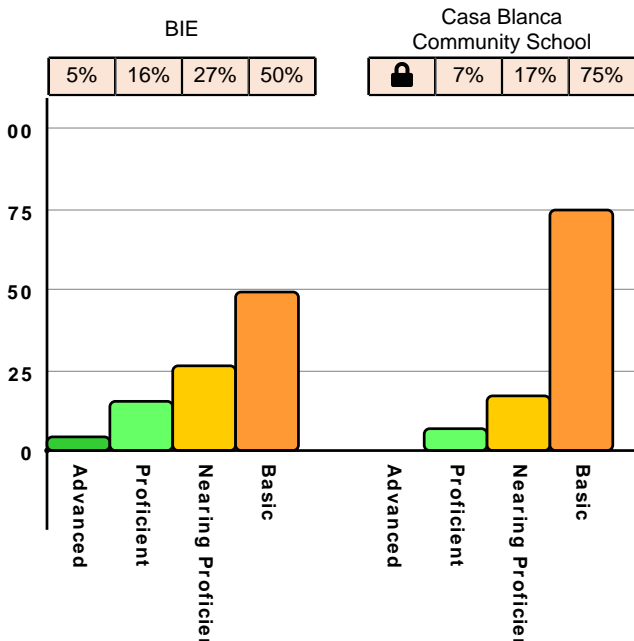

### English Language Arts Proficiency - All Students

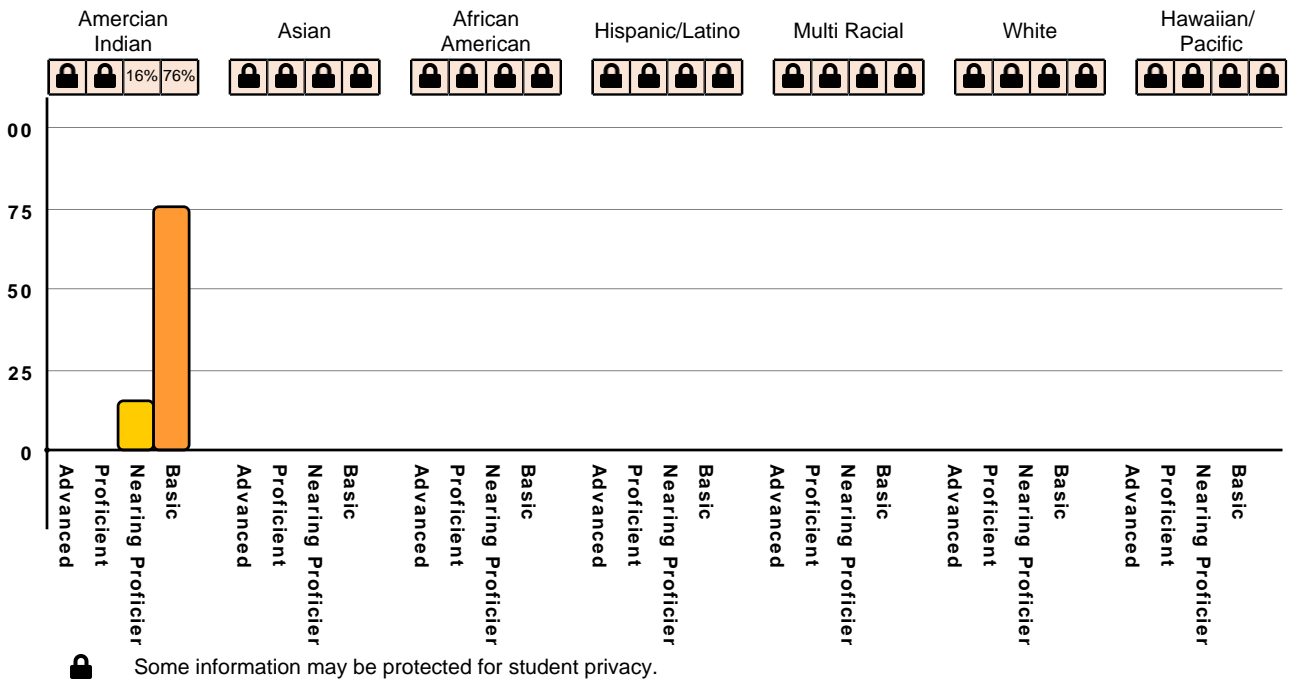

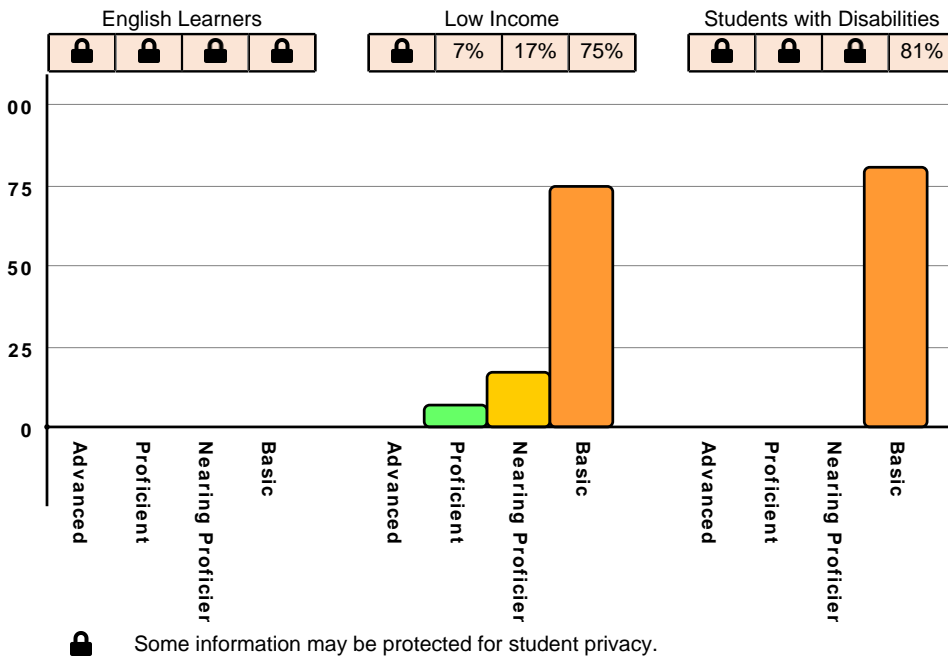

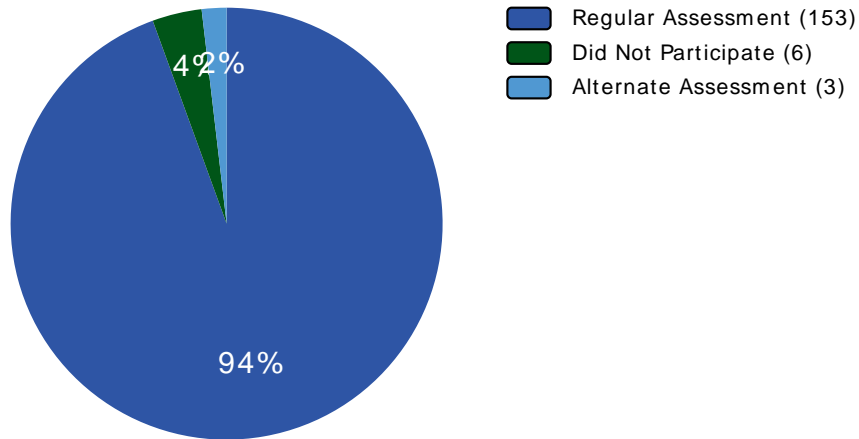

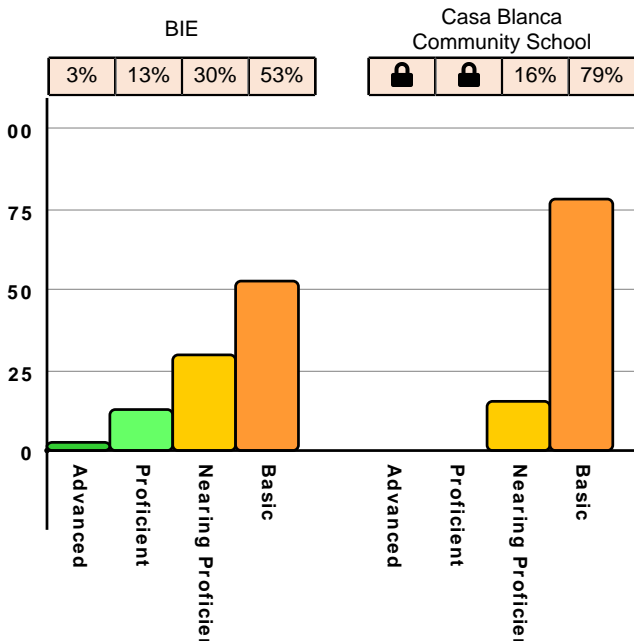

### Mathematics Proficiency - All Students

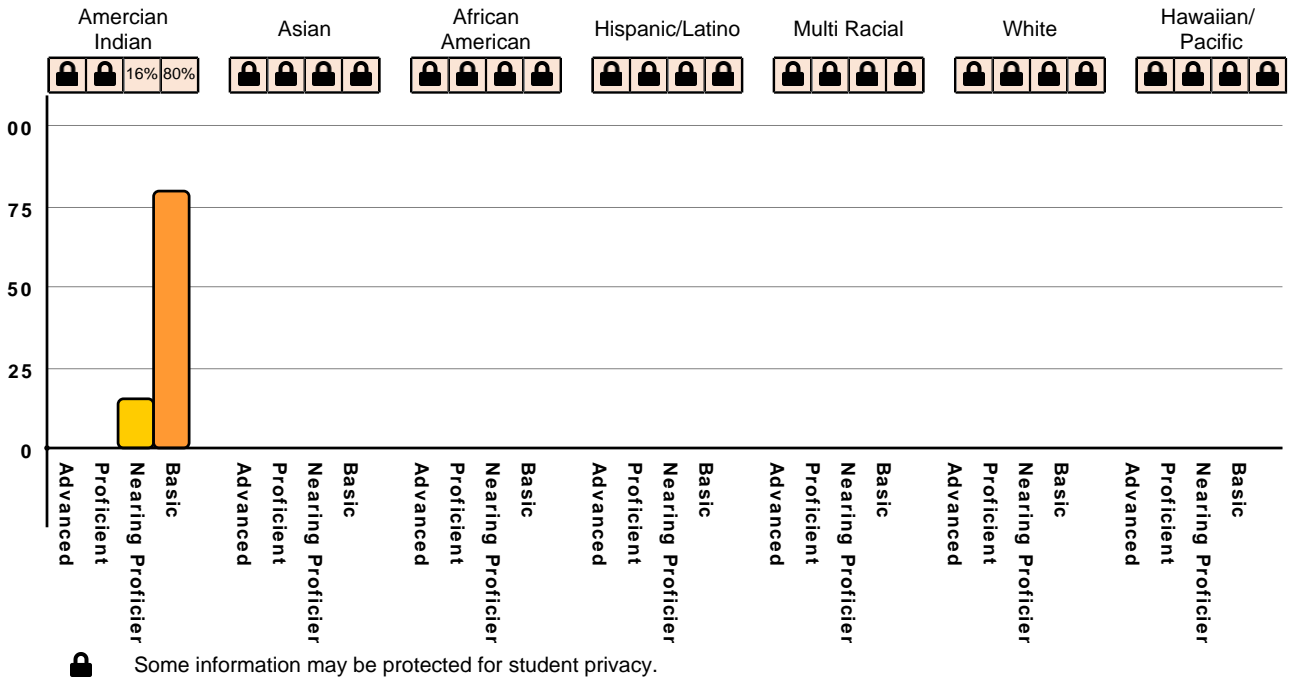

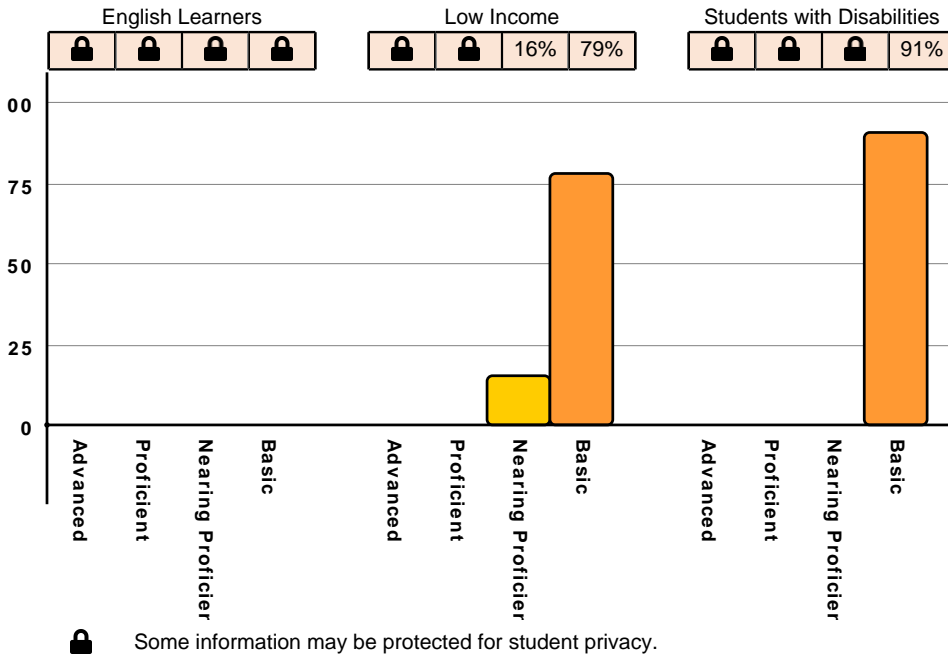

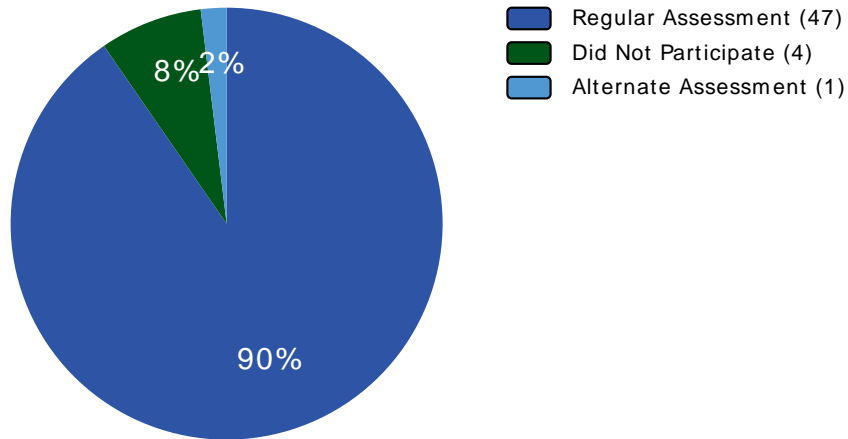

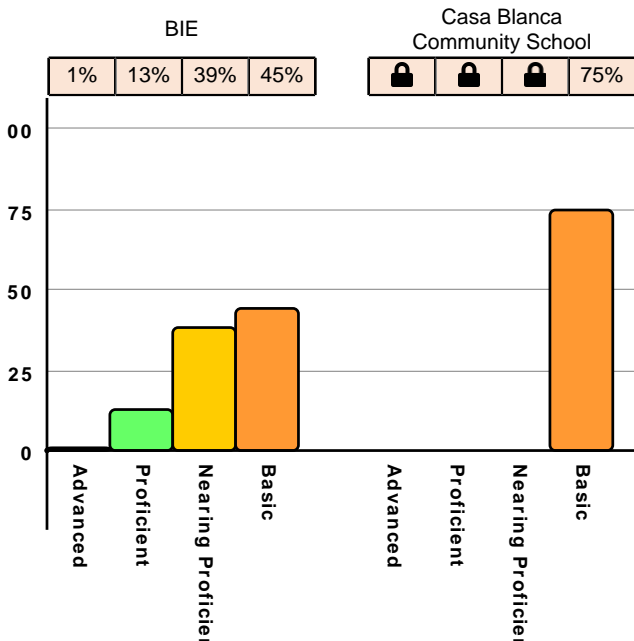

### Science Proficiency - All Students

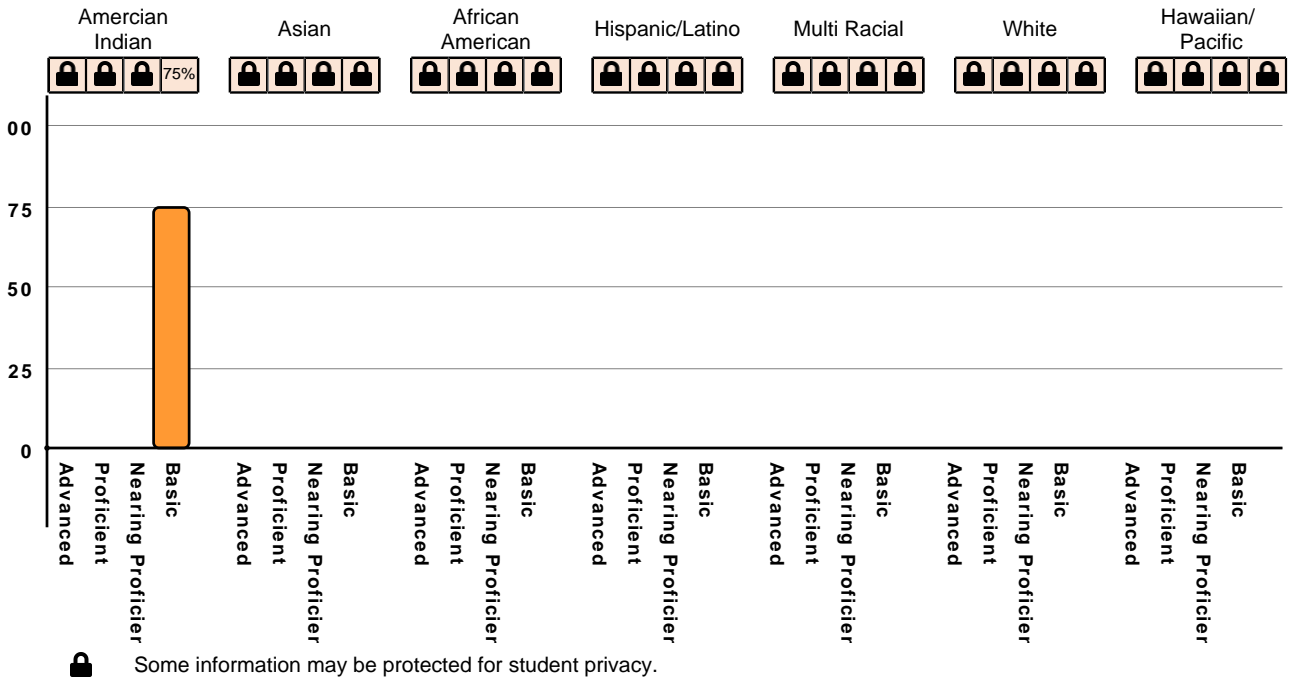

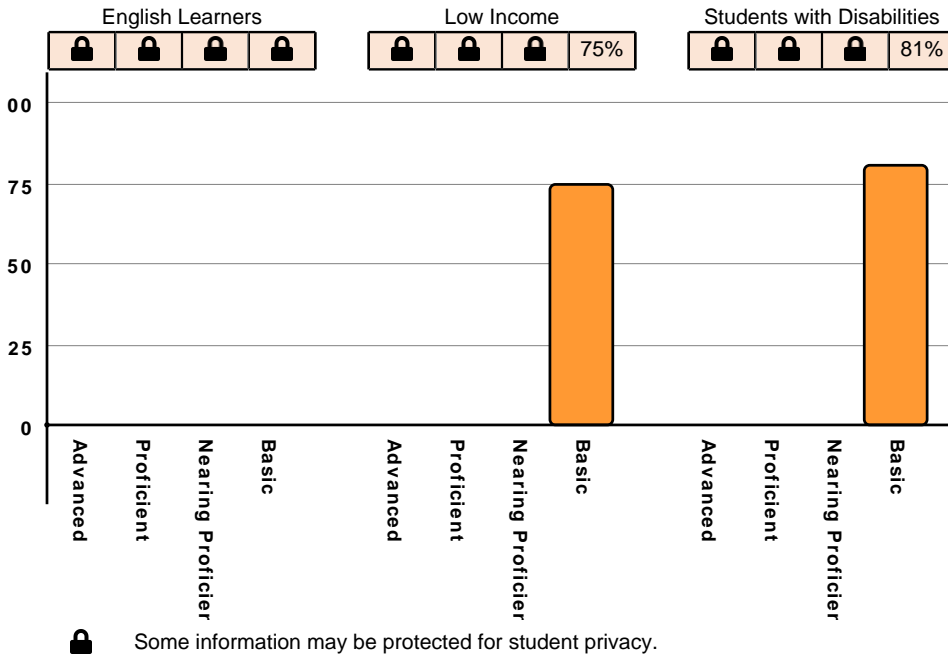

**Early Career Educators:** Educators with four or less years of experience.

An **Emergency Certificate** is issued to an educator who holds, or is eligible to hold, a teaching license but has not met the requirements for certification in a specific content area. An emergency certificate is issued only at the request of the hiring authority (e.g. school/LEA). Emergency certificates are generally valid for up to three years (or up to six years in the case of skilled and technical science teachers) unless revoked. Emergency certificates are not issued for all content areas.

**Out-of-field teachers** taught at least one course outside their licensed content area. While teachers holding an emergency certificate or certificate of eligibility are identified as teaching out-of-field in this analysis, these licensed educators are working towards full certification in the appropriate content areas.

**Other Credential Educators** hold a Temporary, Emergency, or Provisional License/Certification type AND they are teaching one or more courses as a primary or secondary teacher in the subject area of the credential.
