




Enrollment by Race/Ethnicity







Graduation Rate by Race/Ethnicity





Graduation rates are calculated as prescribed by the National Center for Education Statistics (NCES), which provides data to the federal reporting system. In accordance with NCES requirements, the Bureau of Indian Education uses the 4k-year adjusted cohort graduation rate which is defined as the number of first-time 9th grades who graduate with a regular high school diploma in 4 years. Graduation rates do not include students who earn alternate diplomas or certificates.





68.83% of students participated in the English Language Arts Assessment. The goal is 95% or higher.


English Language Arts Proficiency - All Students





49.15% of students participated in the Mathematics Assessment. The goal is 95% or higher.


Mathematics Proficiency - All Students



9.72% of students in this school demonstrated proficiency on this assessment by scoring in the "Meets" or "Exceeds" category. That is below BIE average of 10.78%.




