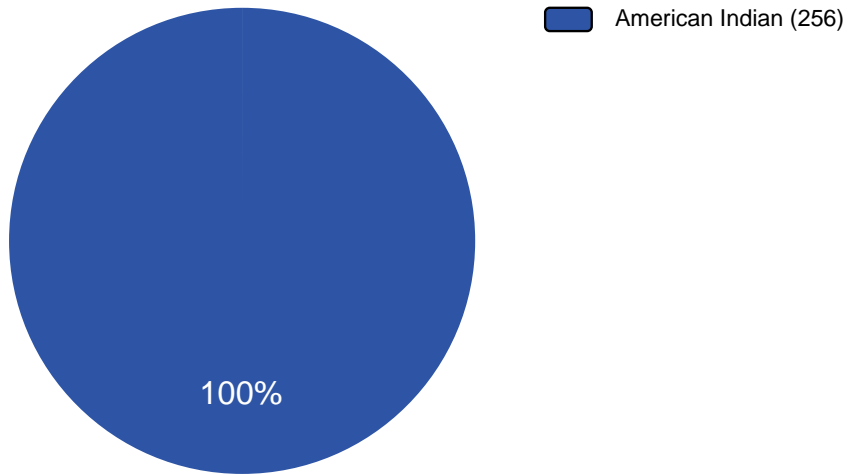

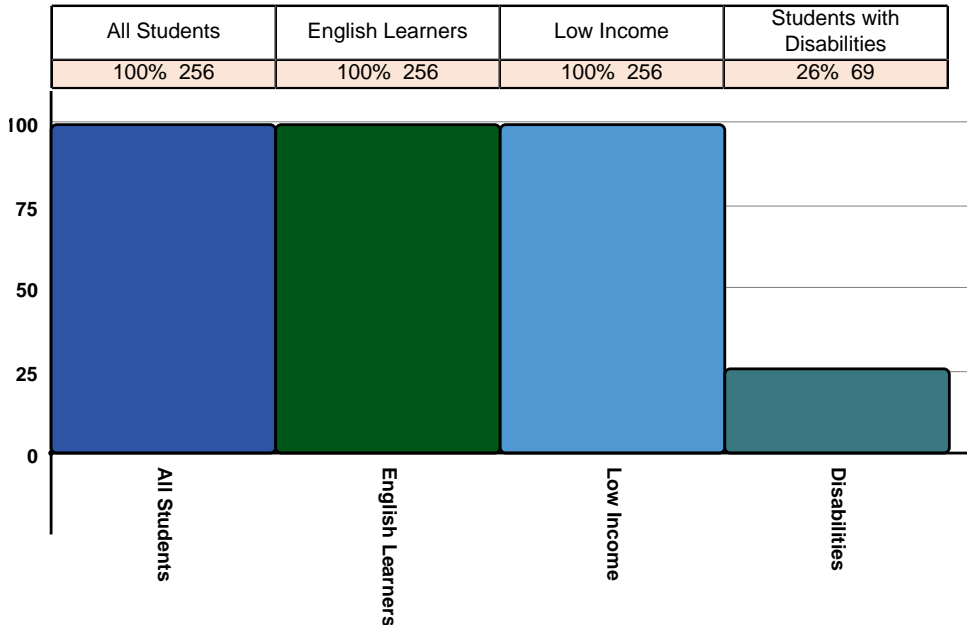

Enrollment by Race/Ethnicity

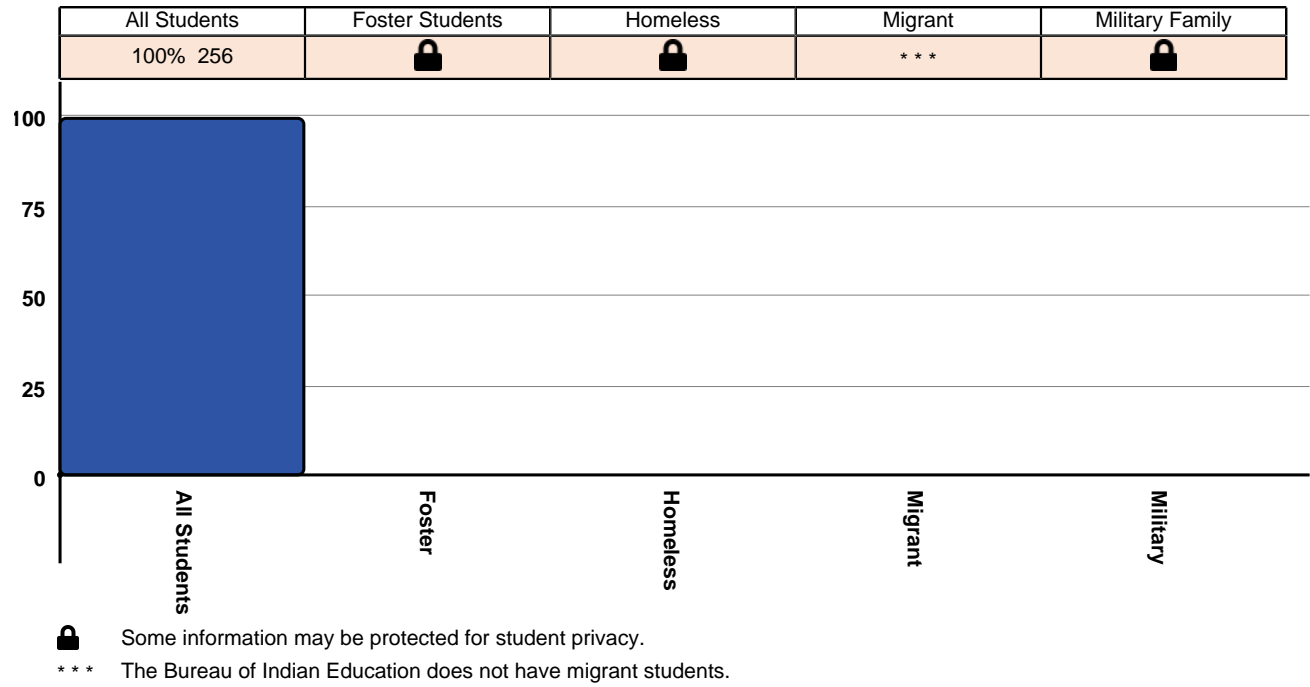


Enrollment by Other Characteristics

The student count is the main base of funding for the Bureau of Indian Education, based on Title 14 of the Bureau of Education Code, and includes varied levels of funding based on educational needs. This count does not include students who enrolled after October 1st. It is also independent of the ISEP count which is the last Friday of October.

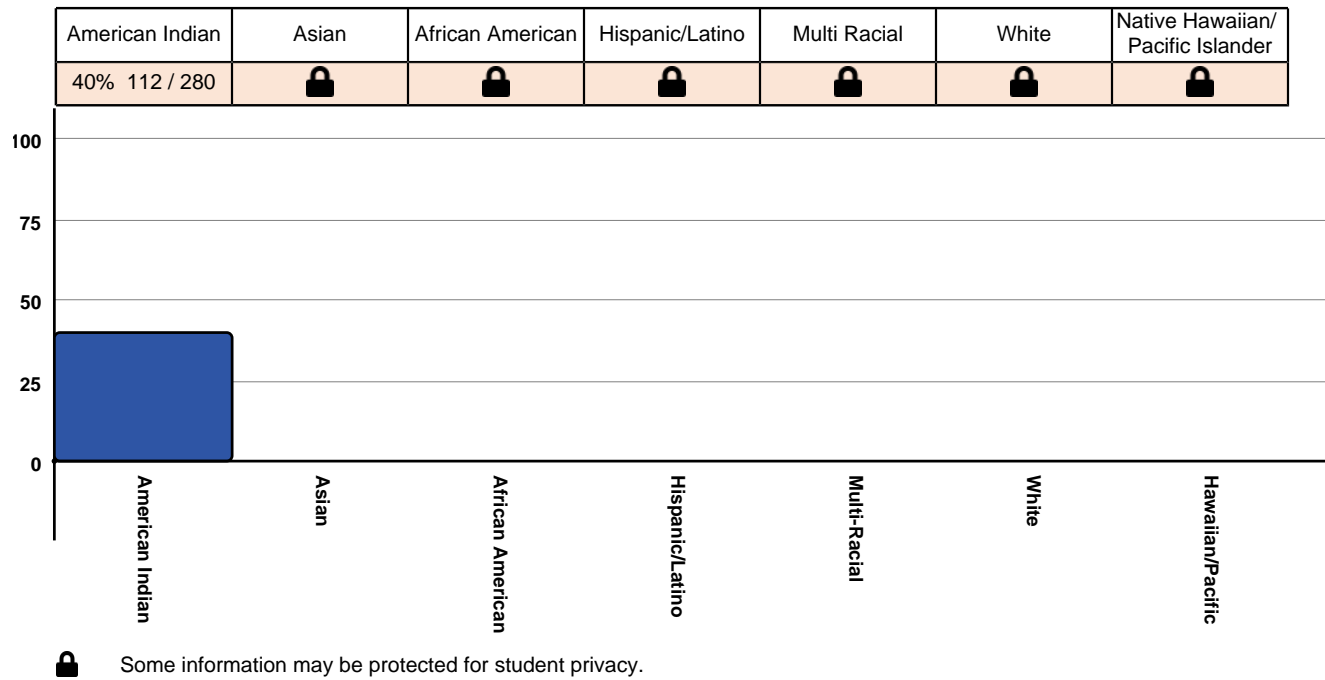

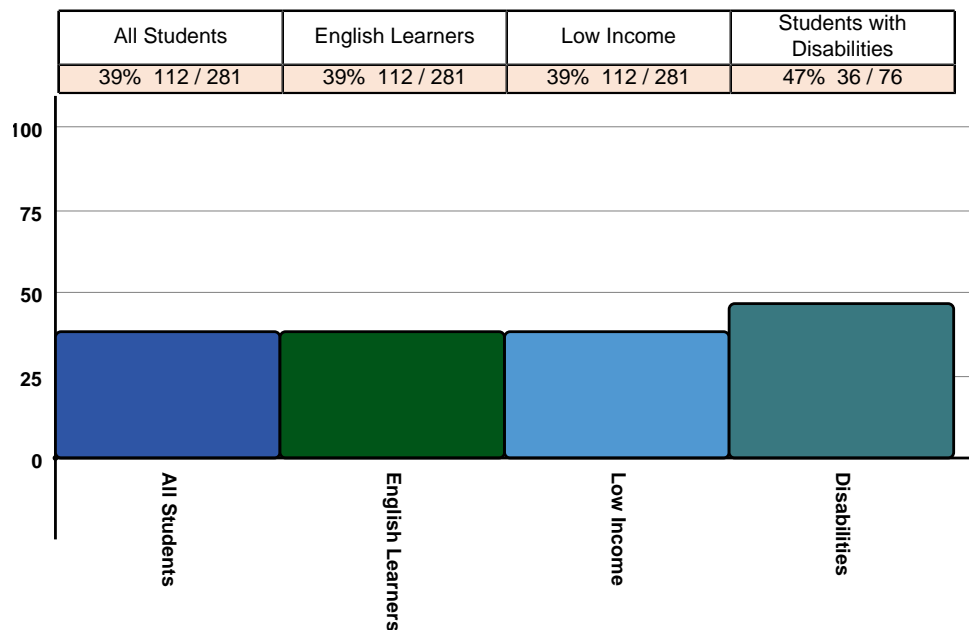

On Track Attendance by Race/Ethnicity

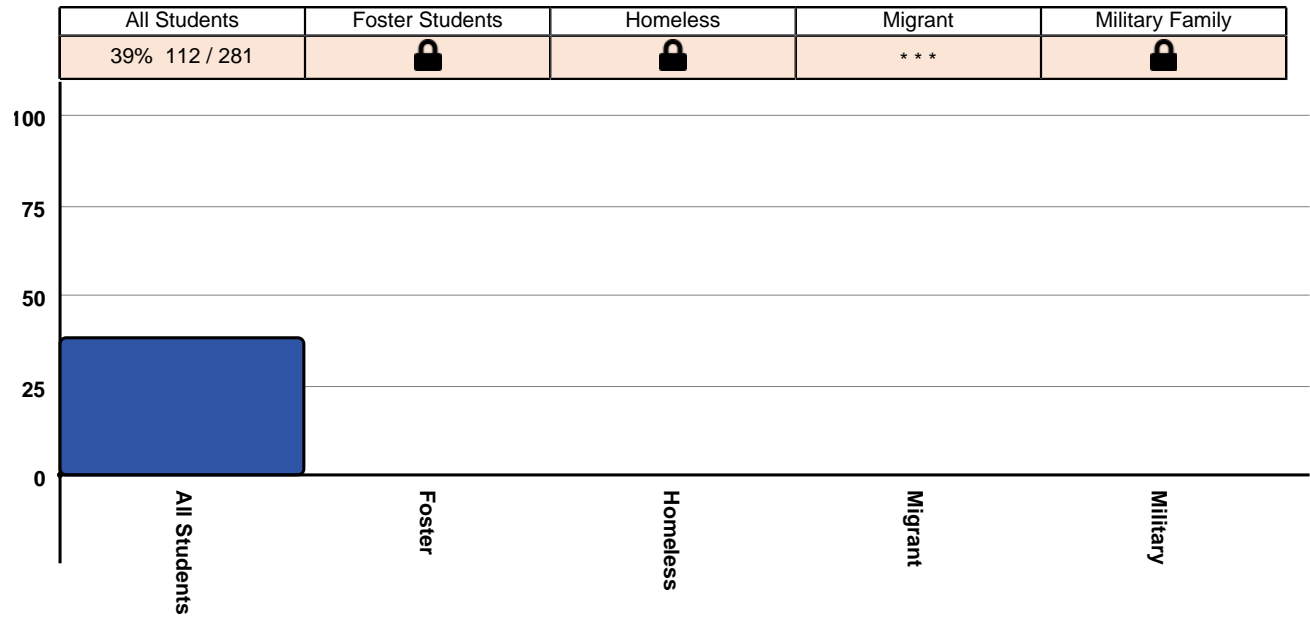


On Track Attendance by Other Characteristics

On-track attendance shares the percentage of students who are not chronically absent. Students must be present and ready to learn to succeed academically. Chronically absent students are those students who are absent for any reason (excused or unexcused), such as illness or out-of-school suspension, for 10% or more of a school's total school time between October 1 and May 31. School Year is represented by the last year of the school year. For example, the 2020-2021 school year is shown as 2021

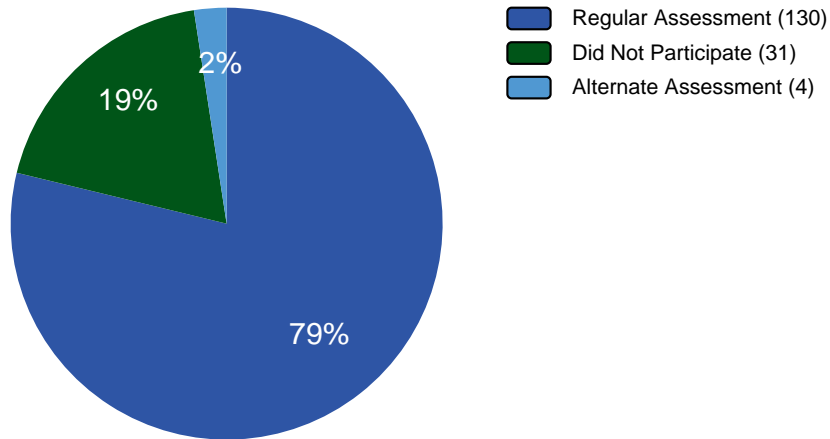

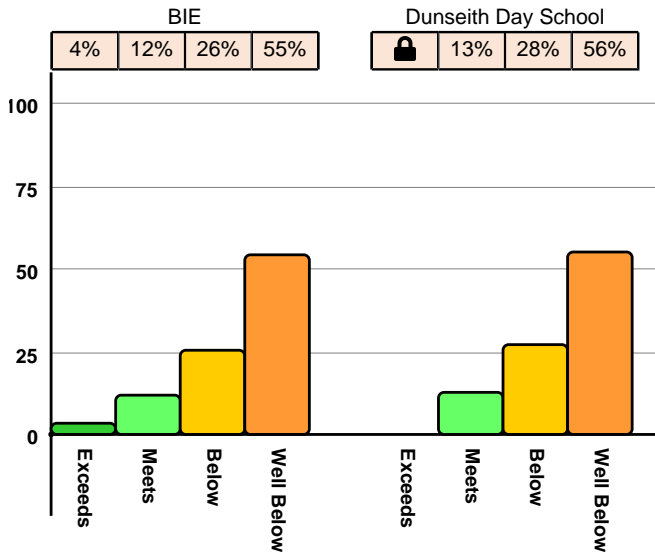

English Language Arts Proficiency - All Students

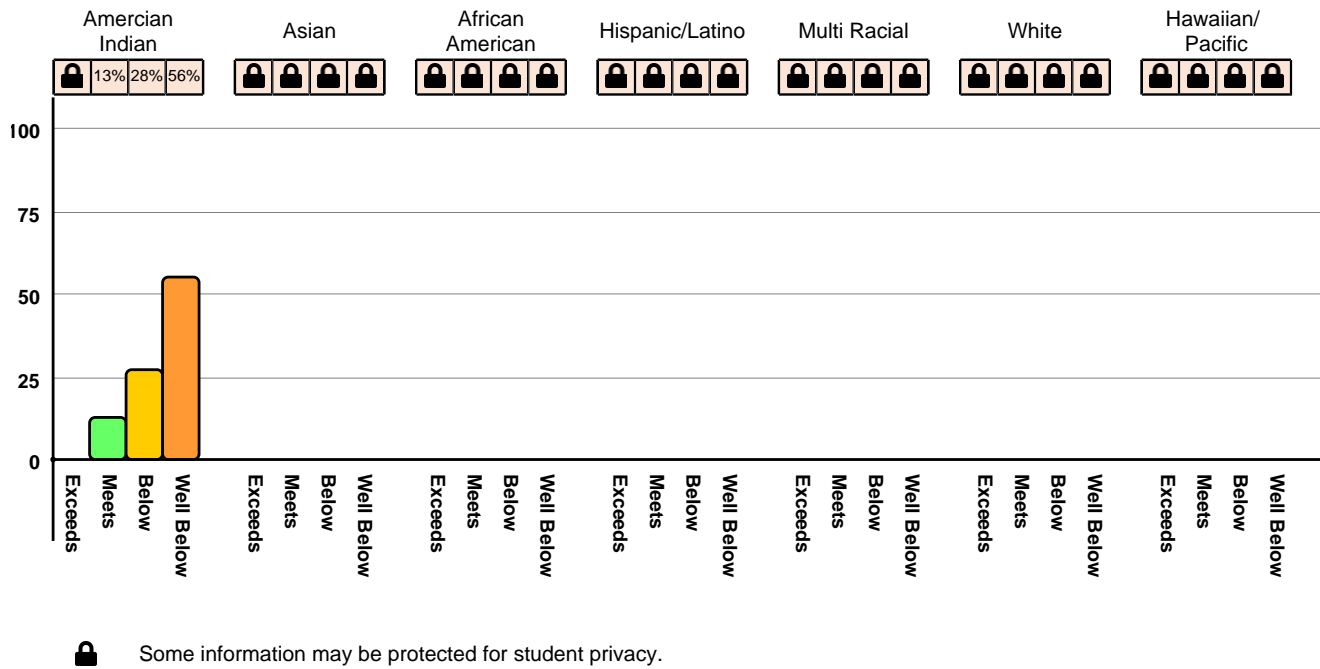


14.93% of students in this school demonstrated proficiency on this assessment by scoring in the "Meets" or "Exceeds" category. That is below BIE average of 17.18%.

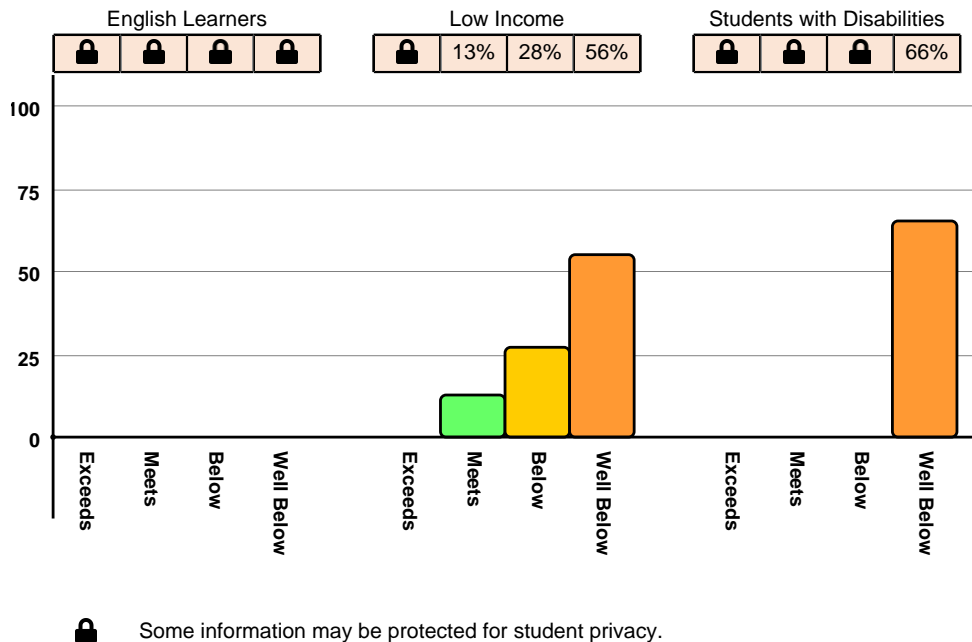

English Language Arts Proficiencies by Race/Ethnicity

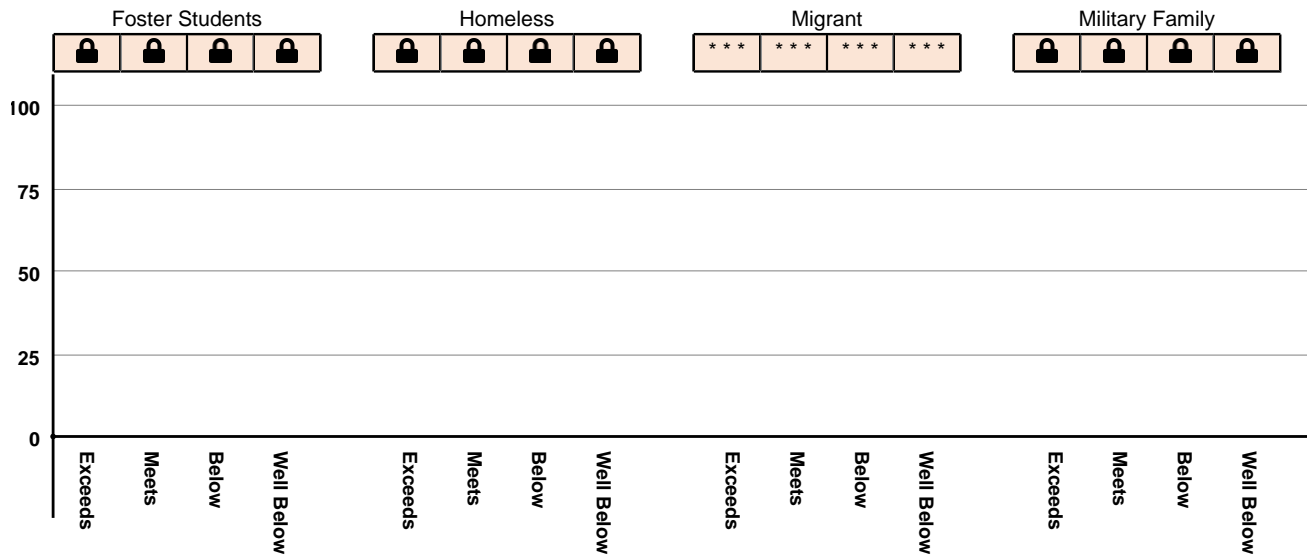



English Language Arts Proficiencies by Other Characteristics

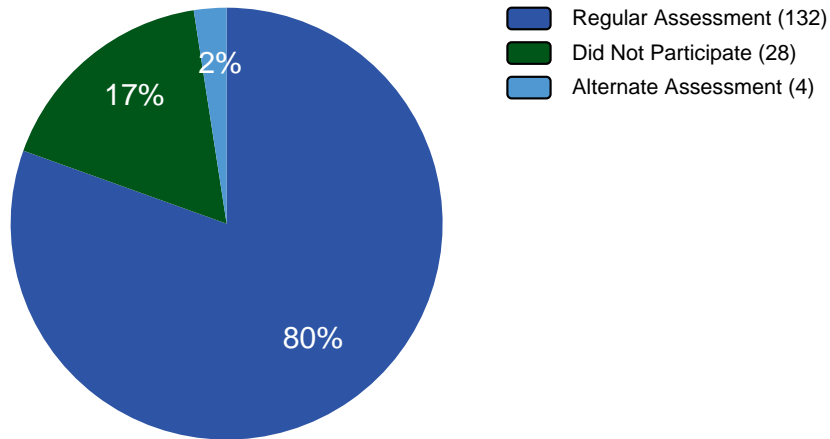

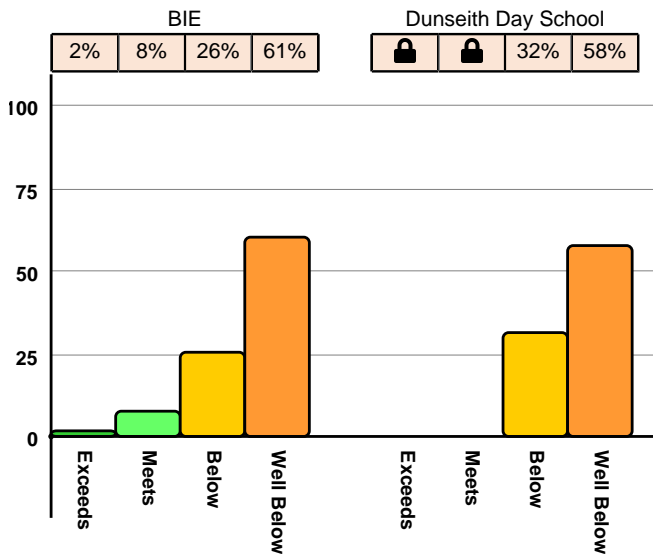

Mathematics Proficiency - All Students

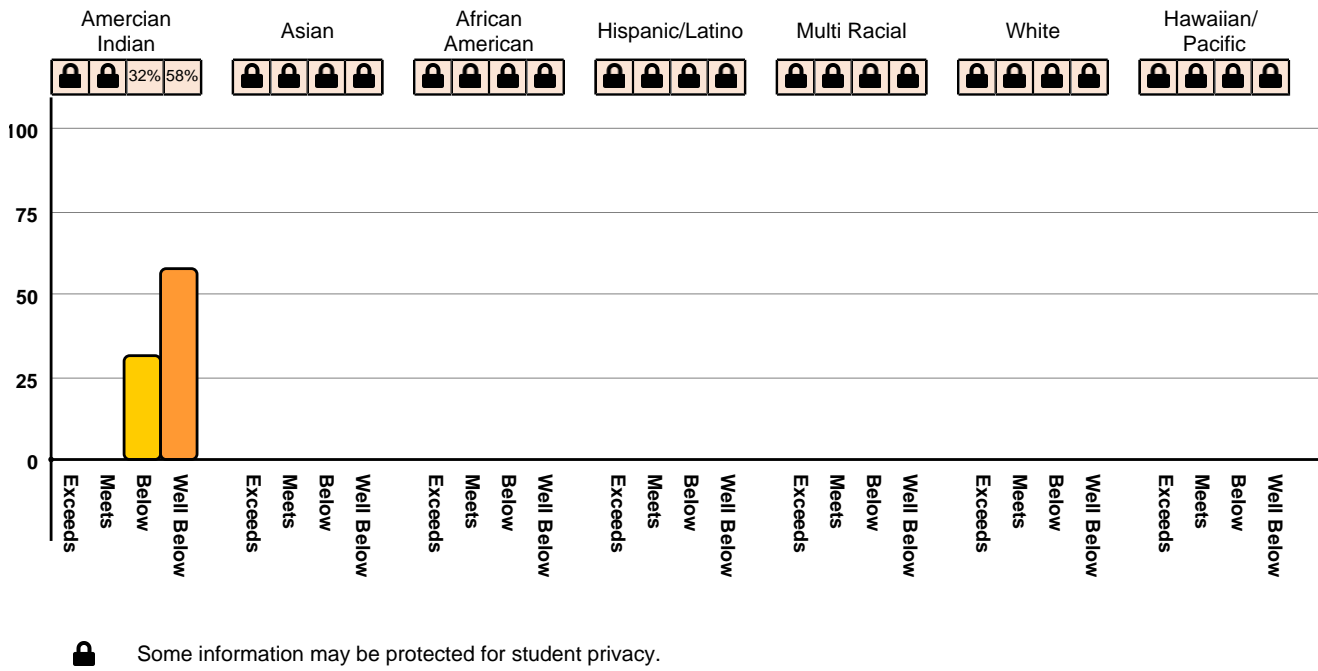


8.82% of students in this school demonstrated proficiency on this assessment by scoring in the "Meets" or "Exceeds" category. That is below BIE average of 10.78%.

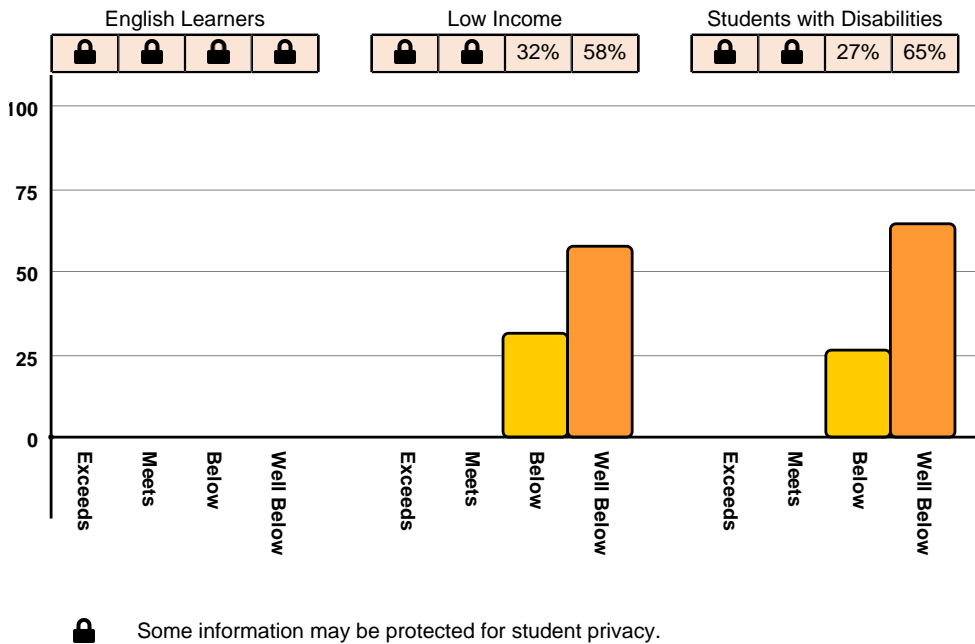

Mathematics Proficiencies by Race/Ethnicity

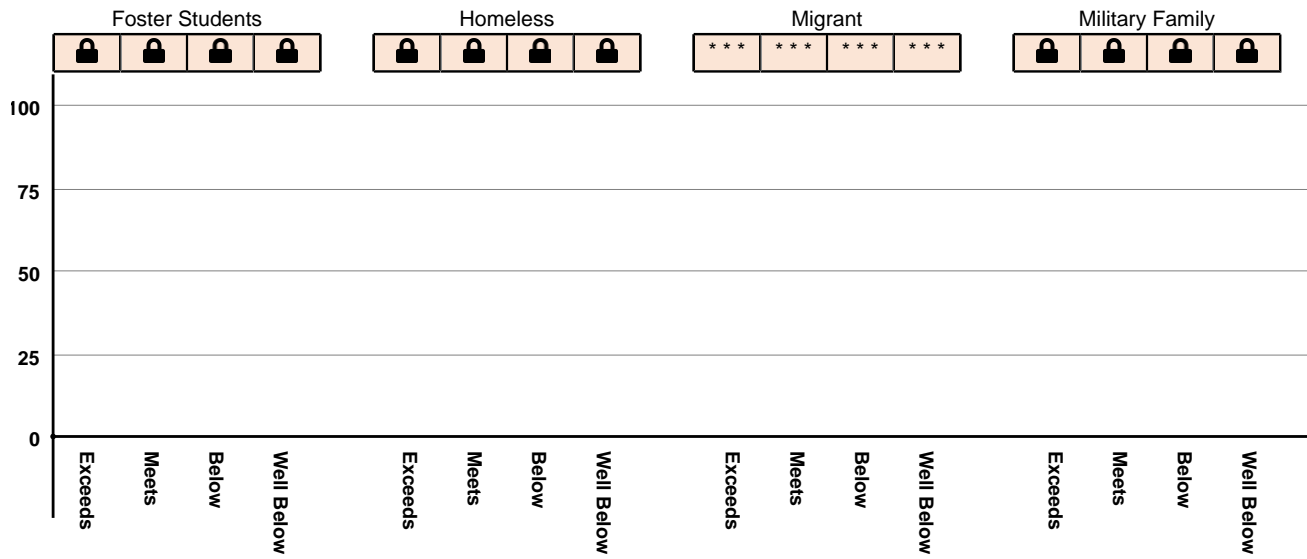



Mathematics by Other Characteristics
