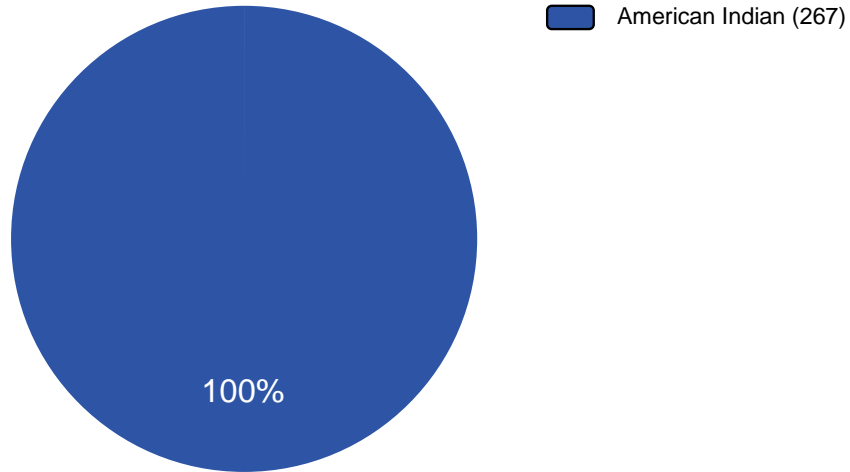

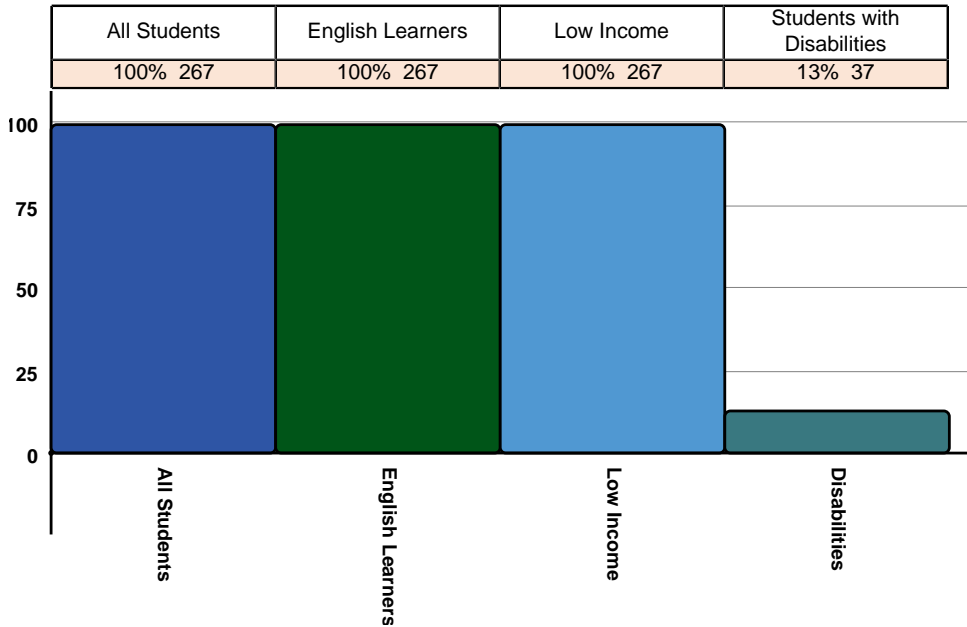

Enrollment by Race/Ethnicity

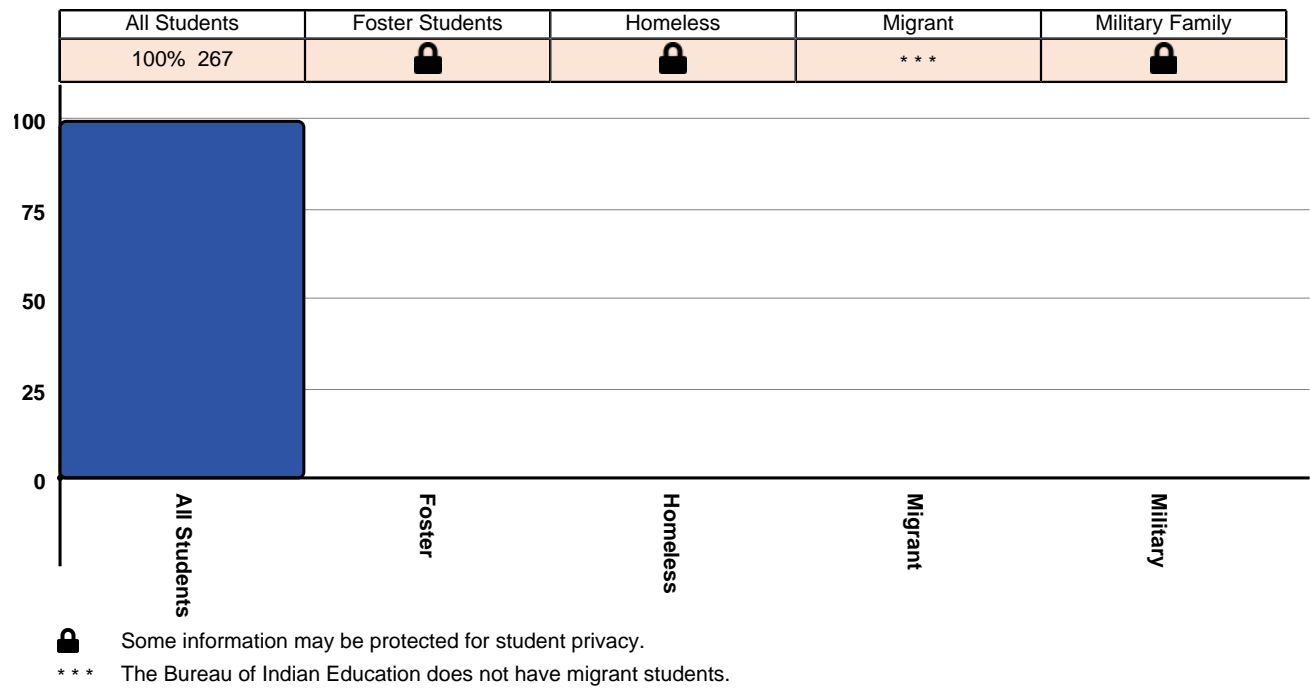


Enrollment by Other Characteristics

Enrollment by Residence

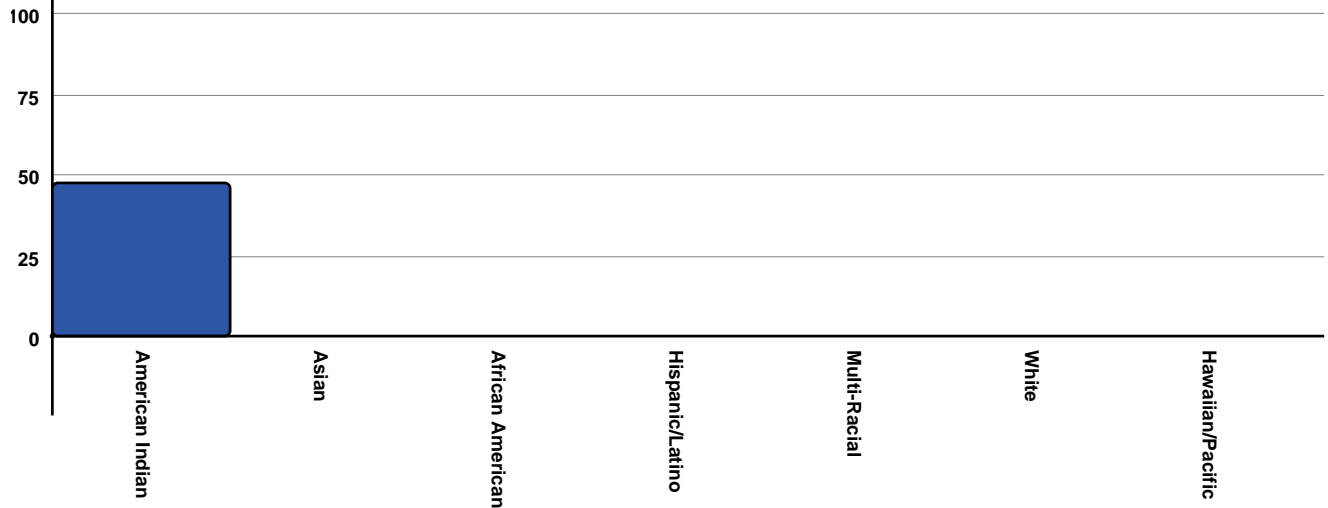

On Track Attendance by Race/Ethnicity

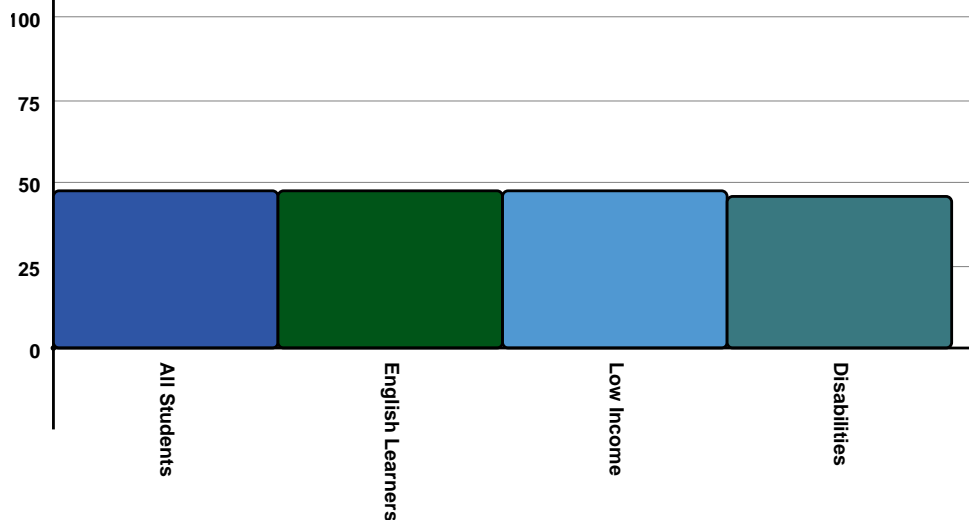

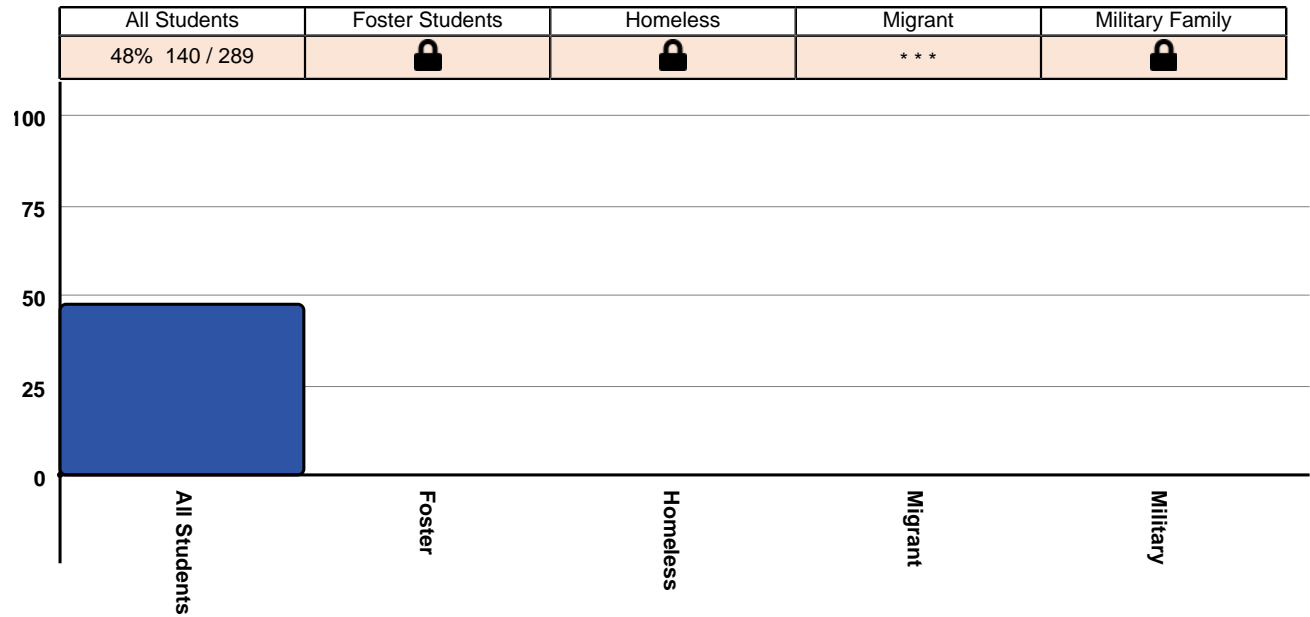

On-track attendance shares the percentage of students who are not chronically absent. Students must be present and ready to learn to succeed academically.
