




Enrollment by Race/Ethnicity









Graduation Rate by Race/Ethnicity





In accordance with NCES requirements, the Bureau of Indian Education uses the 4k-year adjusted cohort graduation rate which is defined as the number of first-time 9th grades who graduate with a regular high school diploma in 4 years. Graduation rates do not include students who earn alternate diplomas or certificates.





97.39% of students participated in the English Language Arts Assessment. The goal is 95% or higher.


English Language Arts Proficiency - All Students



17.45% of students in this school demonstrated proficiency on this assessment by scoring in the "Meets" or "Exceeds" category. That is above BIE average of 17.18%.









96.73% of students participated in the Mathematics Assessment. The goal is 95% or higher.


Mathematics Proficiency - All Students



7.43% of students in this school demonstrated proficiency on this assessment by scoring in the "Meets" or "Exceeds" category. That is below BIE average of 10.78%.




