




## Enrollment by Race/Ethnicity









#### Graduation Rate by Race/Ethnicity









### English Language Arts Proficiency - All Students











38.55% of students participated in the Mathematics Assessment. The goal is 95% or higher.


### Mathematics Proficiency - All Students




