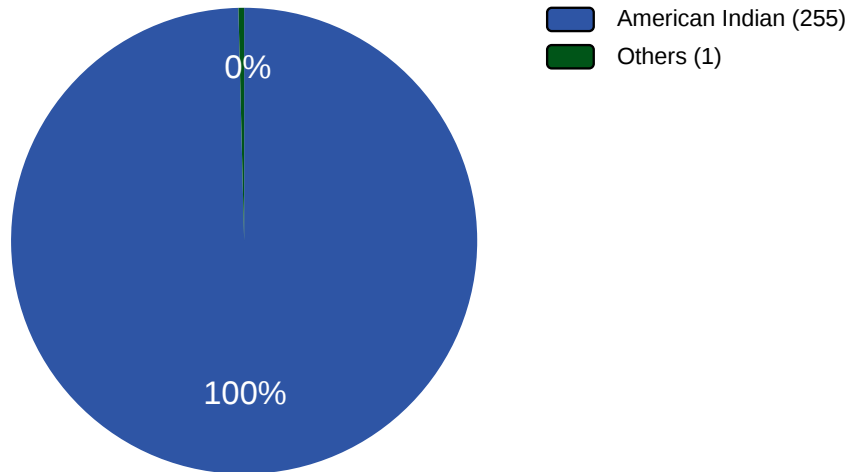

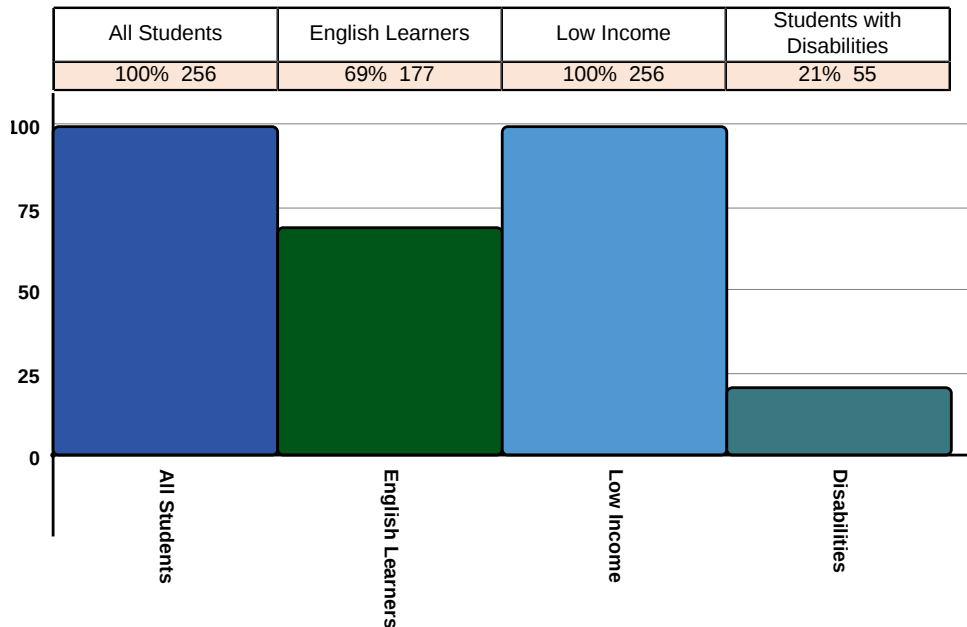

Enrollment by Race/Ethnicity

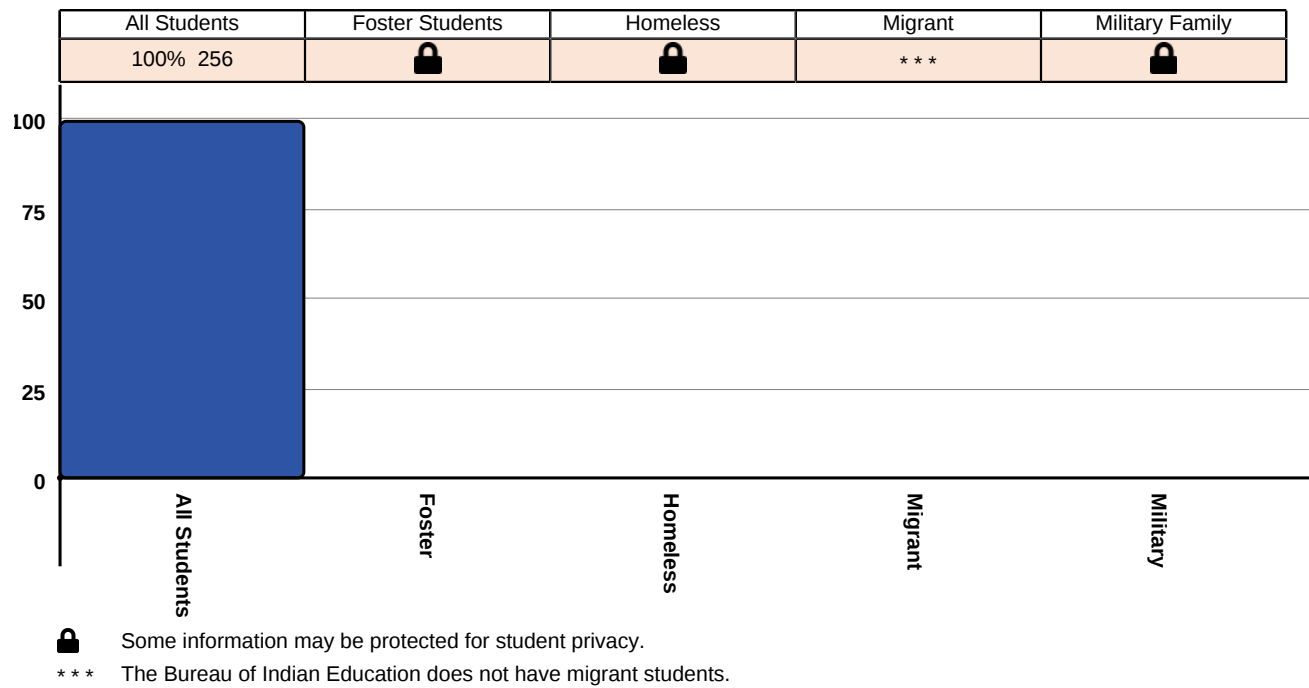


Enrollment by Other Characteristics

Enrollment by Residence



A snapshot of enrollment in the Bureau of Indian Education is collected every year on the first business day in October. The student count is the main base of funding for the Bureau of Indian Education, based on Title 14 of the Bureau of Education Code, and includes varied levels of funding based on educational needs. This count does not include students who enrolled after October 1st. It is also independent of the ISEP count which is the last Friday of October.

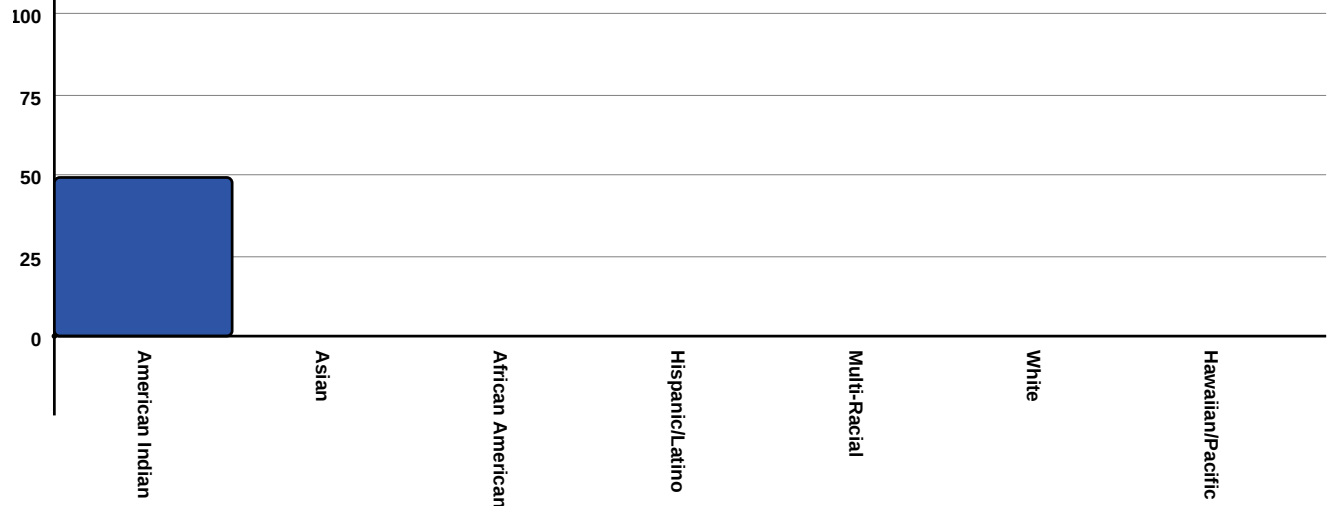

On Track Attendance by Race/Ethnicity

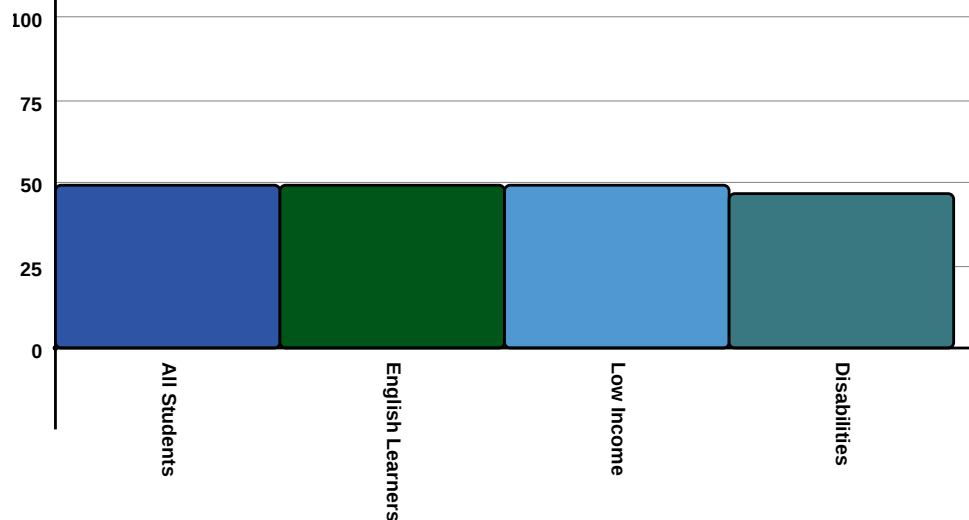

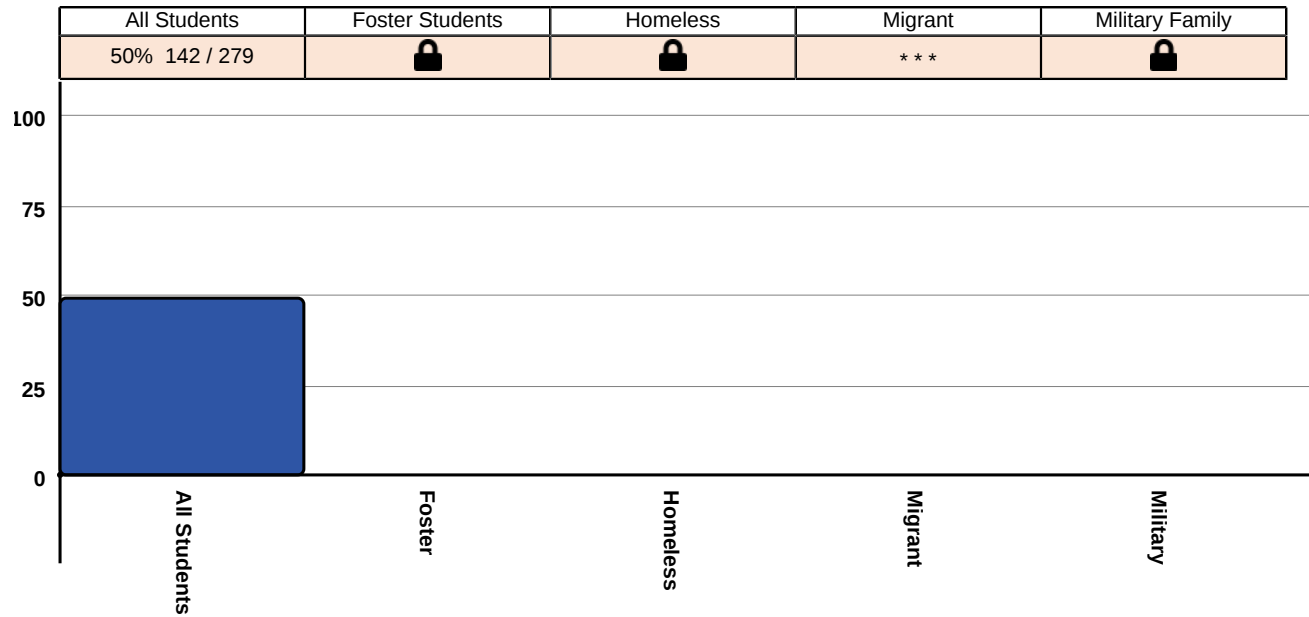

The Bureau of Indian Education does not have migrant students.

On-track attendance shares the percentage of students who are not chronically absent. Students must be present and ready to learn to succeed academically. Chronically absent students are those students who are absent for any reason (excused or unexcused), such as illness or out-of-school suspension, for 10% or more of a school's total school time between October 1 and May 31. School Year is represented by the last year of the school year. For example, the 2020-2021 school year is shown as 2021

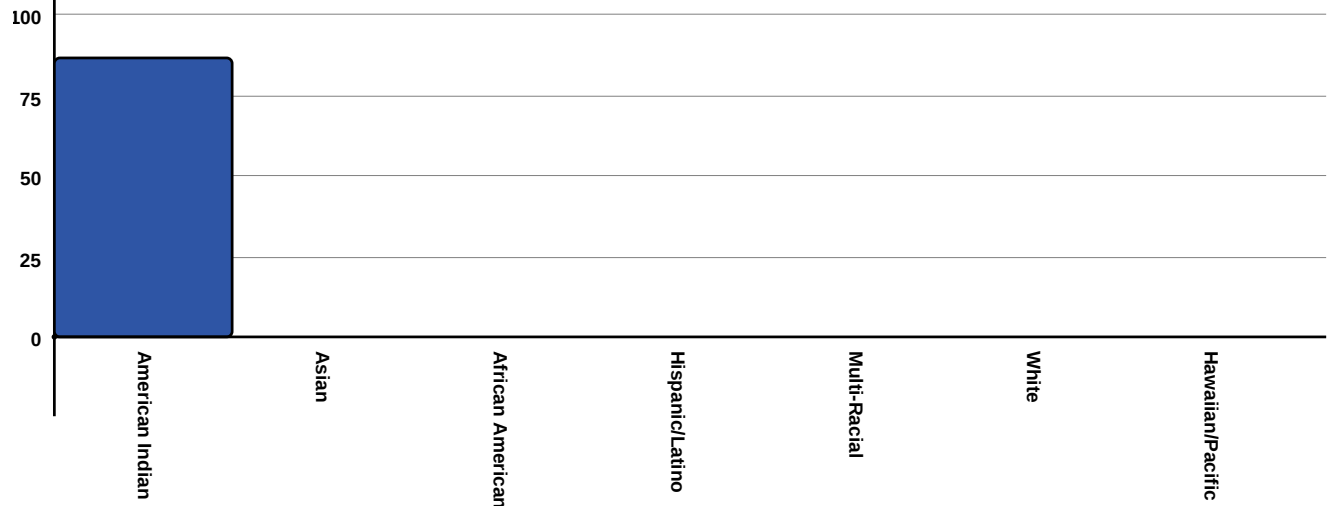

Graduation Rate by Race/Ethnicity

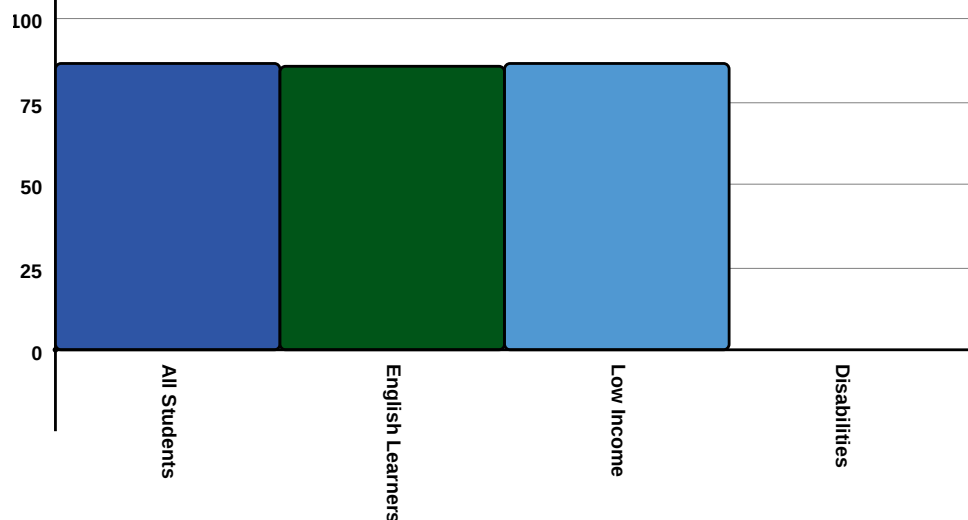

Graduation Rate by Other Characteristics

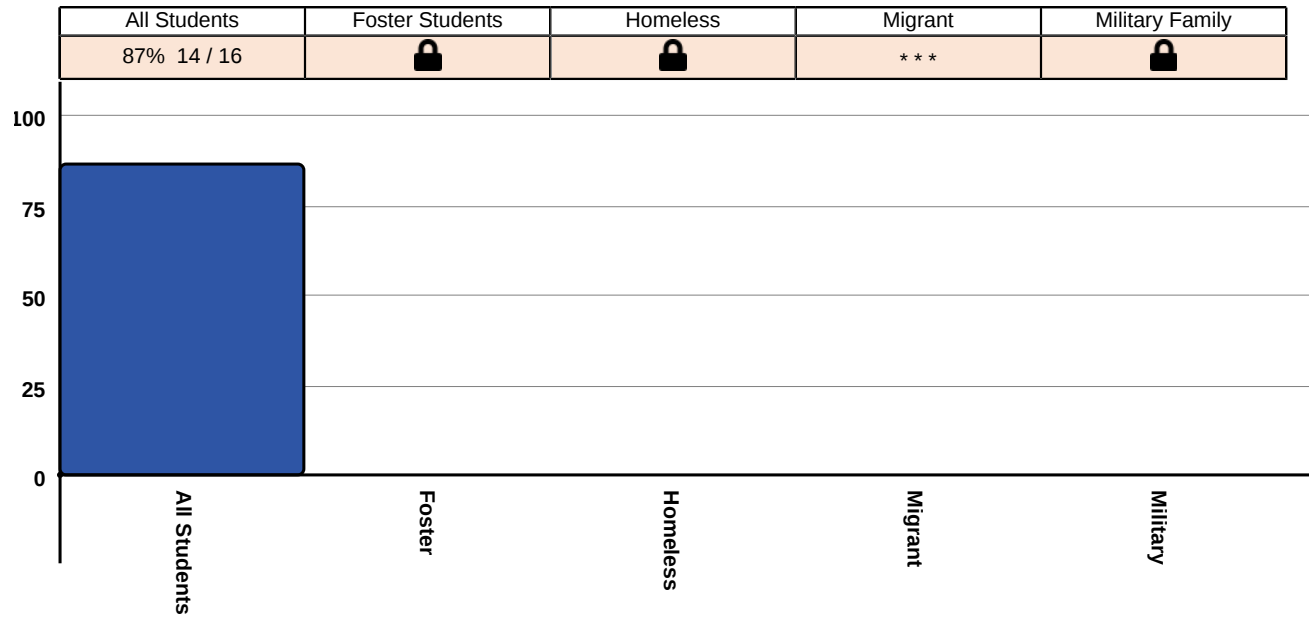

The Bureau of Indian Education does not have migrant students.

Graduation rates represent the percentage of students who graduated high school with a regular diploma. Graduation rates are calculated as prescribed by the National Center for Education Statistics (NCES), which provides data to the federal reporting system. In accordance with NCES requirements, the Bureau of Indian Education uses the 4k-year adjusted cohort graduation rate which is defined as the number of first-time 9th grades who graduate with a regular high school diploma in 4 years. Graduation rates do not include students who earn alternate diplomas or certificates.

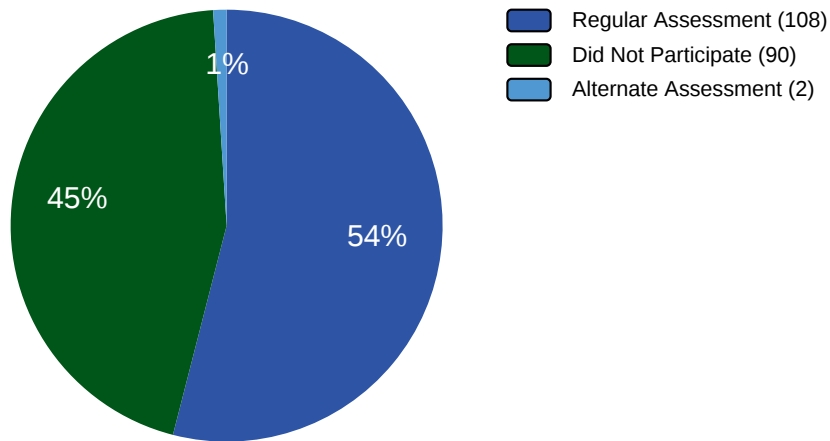

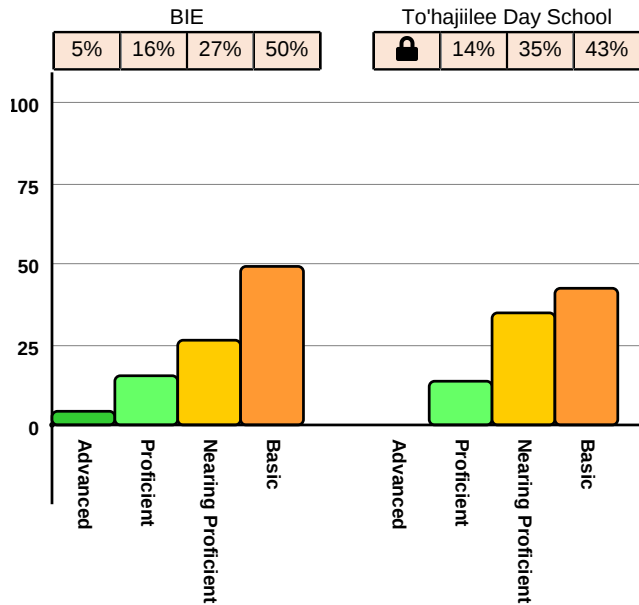

English Language Arts Proficiency - All Students



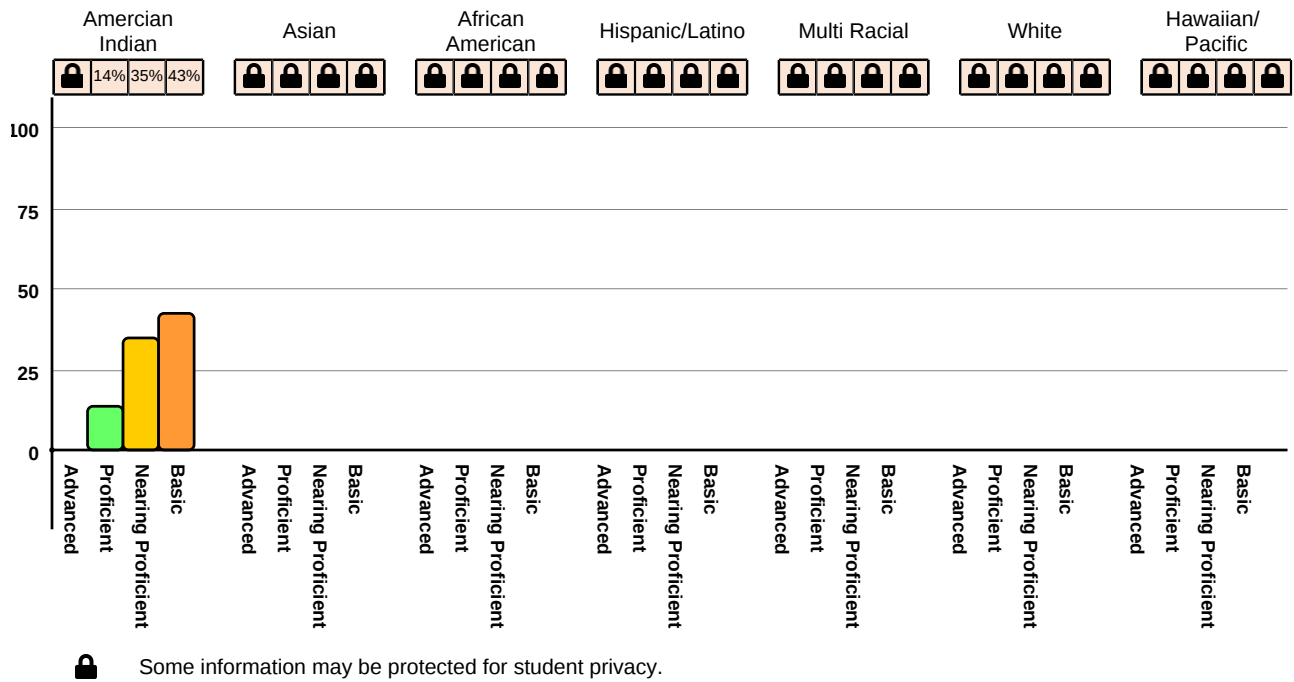

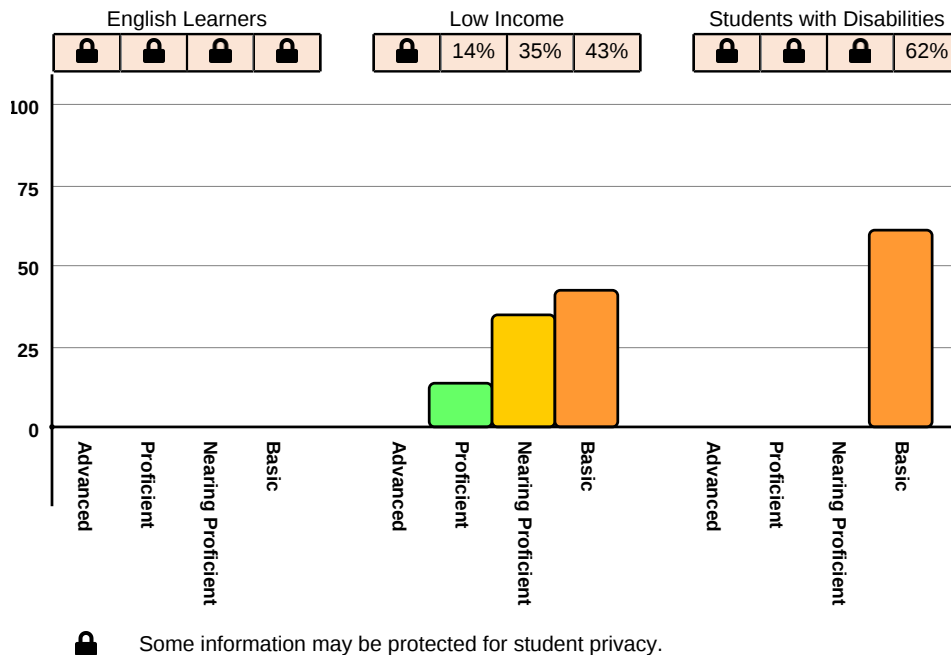

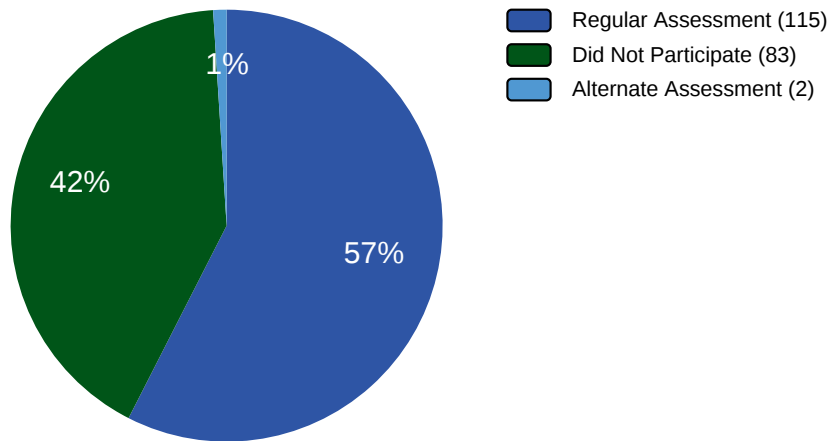

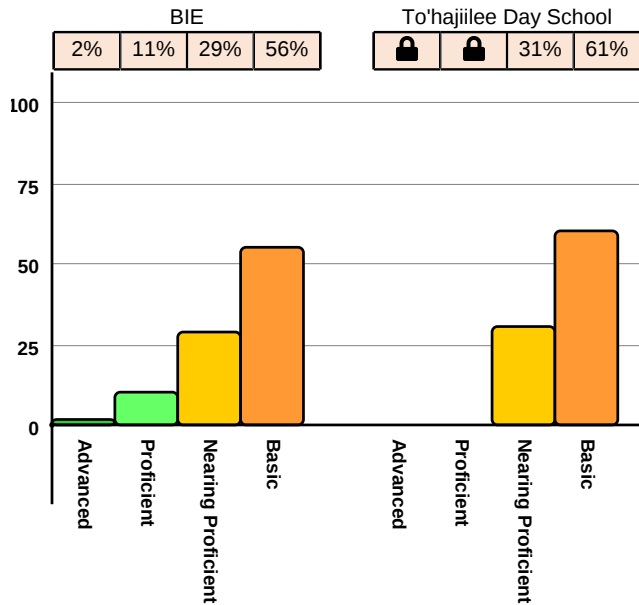

Mathematics Proficiency - All Students



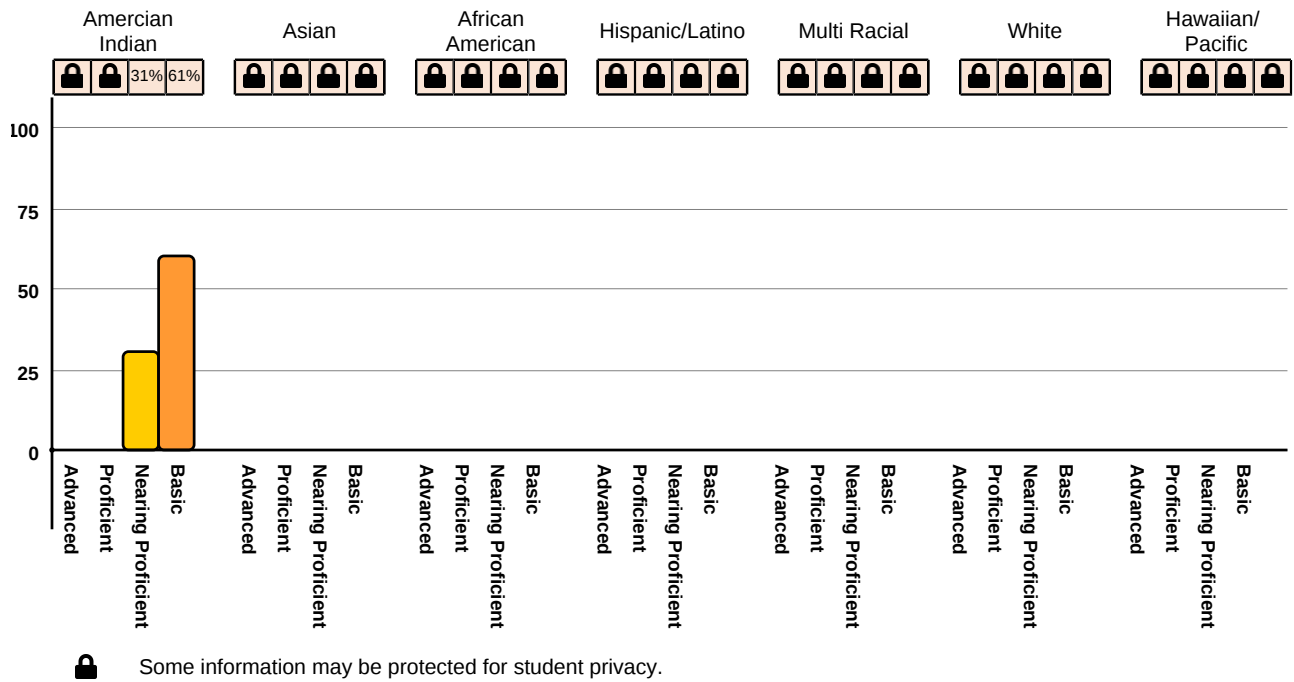

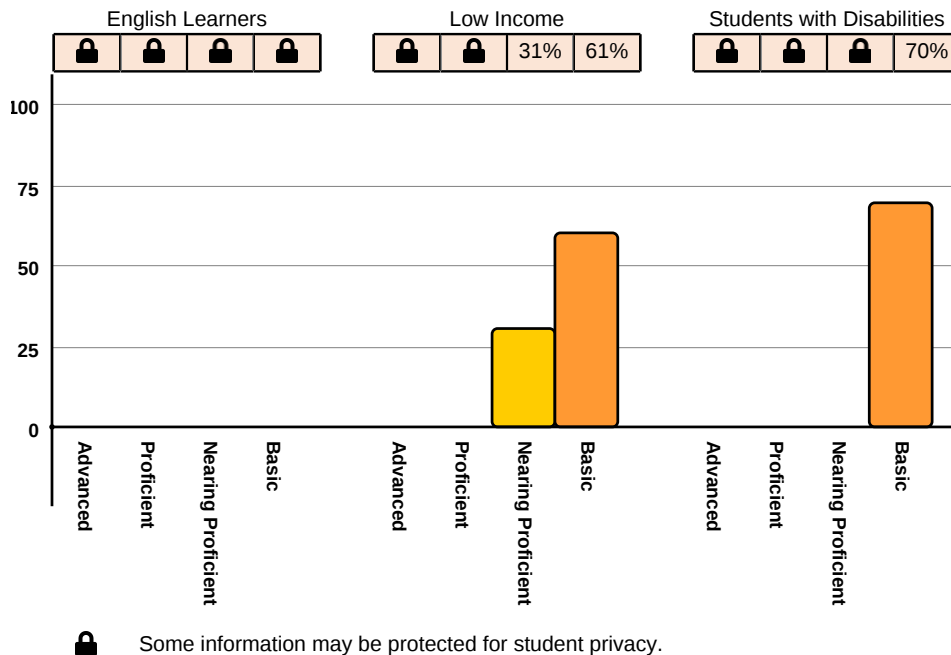

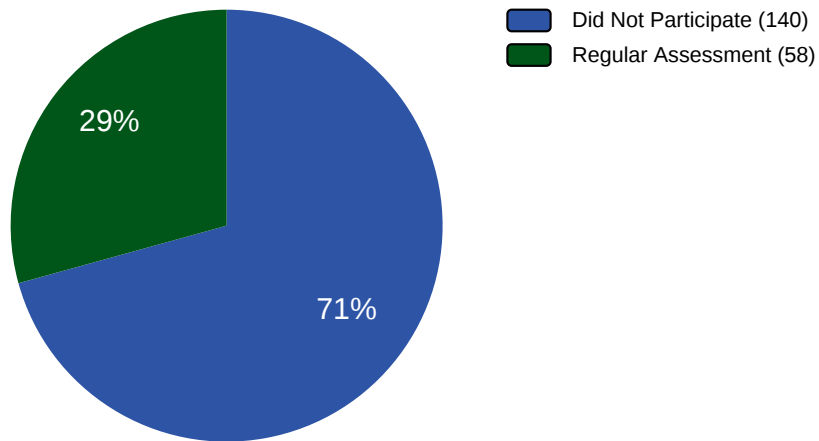

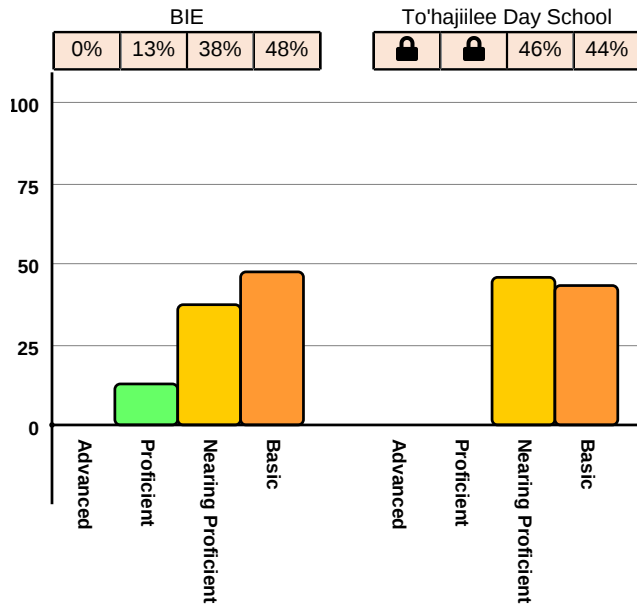

Science Proficiency - All Students



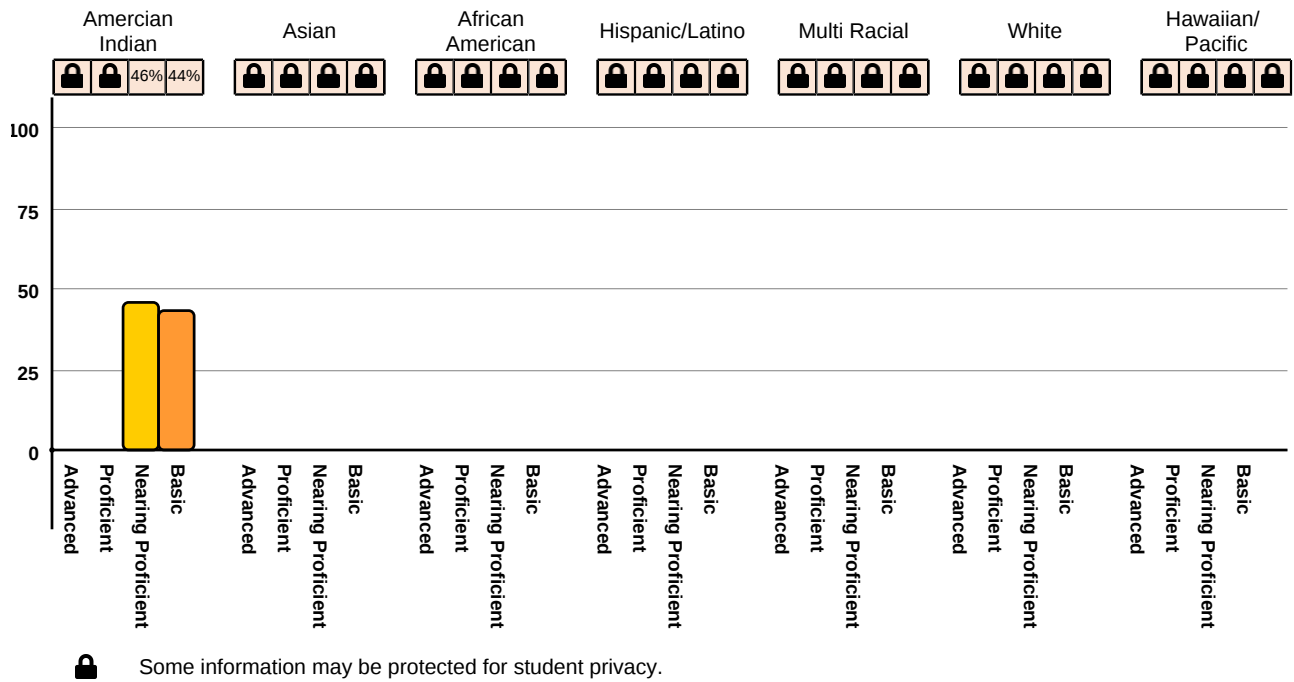

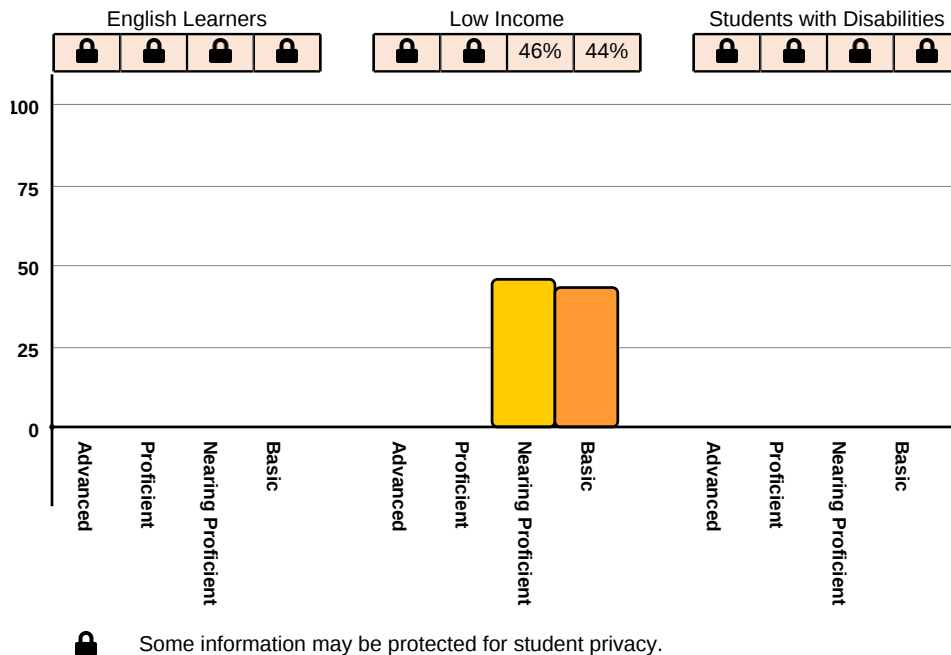

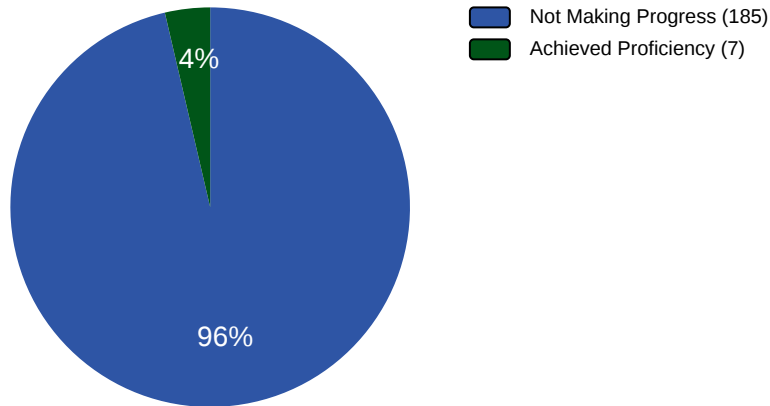
English Learners

School Count:	192 out of 279 students in this school are English Learners. That is 68.82% of the student population.
Making Progress:	0 out of 192 students are making progress to become proficient. That is 0% of the English Learner students.
Achieved Proficiency:	7 out of 192 students became proficient. That is 3.65% of the English Learner students.
Not Making Progress:	185 out of 192 students have not yet made progress to become proficient in English. That is 96.35% of the English Learner students.

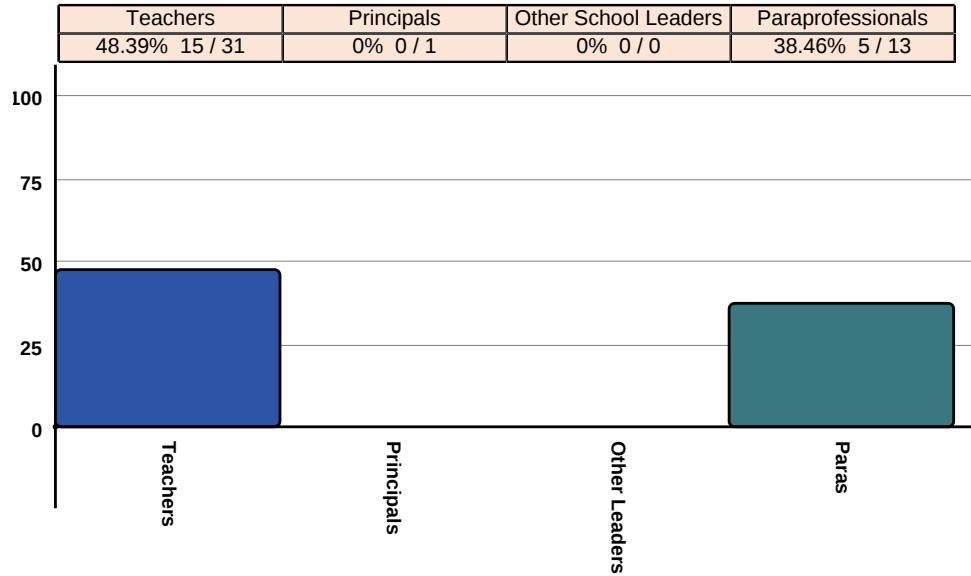

Early Career Educators: Educators with four or less years of experience.

An **Emergency Certificate** is issued to an educator who holds, or is eligible to hold, a teaching license but has not met the requirements for certification in a specific content area. An emergency certificate is issued only at the request of the hiring authority (e.g. school district). Emergency certificates are valid for up to three years (or up to six years in the case of skilled and technical science teachers) unless revoked. Emergency certificates are not issued for all content areas.

Out-of-field teachers taught at least one course outside their licensed content area. While teachers holding an emergency certificate or certificate of eligibility are identified as teaching out-of-field in this analysis, these licensed educators are working towards full certification in the appropriate content areas.
