




Enrollment by Race/Ethnicity









English Language Arts Proficiency - All Students




50% of students in this school demonstrated proficiency on this assessment by scoring in the "Meets" or "Exceeds" category. That is above BIE average of 17.18%.









100% of students participated in the Mathematics Assessment. The goal is 95% or higher.


Mathematics Proficiency - All Students







